LODGEMENT OF F.I.R. INTIMATING ATM THEFT
AND TOTAL CASH LOSS OF SBI ATM ID T1BH000160062
AT ARADHYA COMPLEX, MUNSEFDANGA, PURULIA

I am Arindam Chatterjee, presently posted as Chief Manager at SBI Purulia Branch want to lodge F.I.R. intimating theft incident resulting in total cash loss along with ATM machine damage at our ATM site T1BH000160062 at Aradhya Complex, Munsefdanga, Purulia by unknown persons on 11/09/2022 and 12/09/2022 night hours.

The ATM ID was maintained by our empanelled ATM maintenance agency CMS for all type of requirements who had lodged a down call today morning which was attended by their local representative Mr. Debasis Dutta and it was observed the ATM machine was totally damaged along with all ATM cassettes. The cash at the ATM site is totally lost due to the theft incident. He has informed us in the morning 09:50 hours on 12/09/2022 about the theft incident. We have informed the matter to local Police Station over phone and visited the site jointly around 11:00 hours. The total approximate amount of cash loss due to the theft is Rs.35.10 lacs. We have also lodged for CCTV footage claim with the respective vendor and we will provide you the footages when we receive from the vendor.

Please lodge the FIR in this matter and please find the culprits who has damaged public property and put our bank at loss by the act of vandalism.
