The Inspector-in-Charge Purulia (T) PS

Sub: Prayer for start a specific case.

Sir,

In producing herewith accused Sazid Ansari (49 yrs) S/O- Md. Sahim Ansari of Near Janisar Akhara, Upper Kulhi, Amtal, Dhanbad, PS - Jharia, Dist- Dhanbad, Jharkhand - 828111 alongwith one seized oil tanker bearing No JH10BA - 7805 having Engine No. 497SPTC43KVY641876, Chassis No. MAT524005ESN08132. I, ASI Gouri Charan Mahadani received a secret source information vide Purulia (T) PS GDE No. 1202 Dated 20.09.2022 and myself alongwith force reached at Goshala More with a view to work out the source information. After waiting few minutes at about 13:35 hrs one vehicle with small tanker is coming towards town area and as per identification of my source. Myself alongwith force stop the vehicle and asked the driver to produce the D/L and all connected papers. On demanding he refused to show any kinds of papers in respect of vehicle as well as diesel. After prolong argument at last he confessed that the diesel coming from Jharkhand side and sold in different area of West Bengal. This type highly inflammable material moving is highly dangerous. The driver confessed that they are used to moving with this vehicle loaded with such type highly inflammable materials. On asking driver ultimately confessed that one Anil Goyel & Sabbir Alam both are of Dhanbad Purano Bazar, Ratanji Road near back side of Dhanbad Rly. Station, PS- Bank More, Dist- Dhanbad, Jharkhand and his associates used to continue this type of practice since long. He also stated that his D/L kept in their custody. As he failed to produce any kind of papers/documents in respect of vehicle bearing No. JH10BA - 7805 as well as the load diesel. So the driver of the vehicle namely Sazid Ansari arrested.

Incource of time myself prepared seizure list which is duly signed by the accused driver Sazid Ansari as well as other witnesses. Myself also prepare a Memo of Arrest and give him a copy of the same. Myself and force thereafter return to PS from Goshala More.

Under the circumstance I pray a specific case may kindly be started under proper section of law against the accused driver and others.
