Sub: Prayer for starting a specific case U/S- 285/286/188/120B IPC & Sec 24/26 of West Bengal Fire Service Act.

Sir,

In producing herewith one accused persons namely Titar Ray (34 yrs) S/O- Sri Madan Ray of Vill- Chandwara, PS- Karthahan, Dist.- Vaishali, Bihar in custody, under proper memo of arrest in original, along with the following seized articles as per original seizure list that is (i) One Tata 407 EX Truck having Registration No- WB03D 1109, Engine No- 497SP67KVY638448, Chassis No- MAT455041E8K26055 (ii) 20 Box of Black Cat Bijili loose Fire Crackers, each box contains 300 Packets × 100 Pices of Fire Crackers (iii) 03 Box of Panda Bijili loose Fire Crackers, each box contains 300 Pakets × 100 Pices of Fire Crackers (iv) 02 Indigo Brand loose Fire Crackers each box contains 300 Packets × 100 Pices of Fire Crackers (v) 01 Cock Brand loose Fire Crackers each box contains 300 Packets × 100 Pices of Fire Crackers.

Today (20.09.2022) at 19:35 hrs while I ASI Nayan Ch. Mondal along with C/254 Karunamoy Bauri, C/11 Kajal Mukherjee engaged in Evening mobile duty vide C.C No-2417/22, Date-20.09.22 at that time received secret source information that one Tata 407 truck Bearing No-WB03D 1109 is coming from Ranchi side with huge quantity of contraband high noise and air polluting fire crackers and fireworks at his vehicle for selling to the public, which have been banned from sell and purchase to public as per the order of Hon'ble High court at Calcutta.

Immediately I informed the matter to I/C Purulia(T) P.S as per the direction of I/C Purulia(T) P.S myself constituted a raiding party with available force at Judge Bungalow more and indicating to stop the vehicle but disobeying the order of uniform Police officer. We able to stopped the vehicle at 19:45 hrs. and on asking his identity he disclosed his name and address and noted above. On demand he could not produce any documents and permission of such huge quantity high explosive fire crackers and air polluting fire crackers and fireworks.

So, there was a reasonable ground to believe that the above noted person convenes of the owner of the vehicle were trying to sell the articles i.e. contraband firecrackers and fireworks illegally without any proper license or permission endangering the human life near residential buildings which may likely to cause hurt or injury to any person without any proper guard which is sufficient against any probable danger to human life from the substance and have also violated the order of the Hon'ble High court.

Accordingly, I have seized aforesaid huge quantities of illegal firecrackers and fireworks under proper seizure list in between 19:55 hrs to 20:25 hrs duly signed by the witnesses and the accused person. Hence, I arrested him after conveying him the ground of arrest vide proper memo of arrest.

Under the above noted facts and circumstances, I am submitting a typed complaint against the accused person noted above and owner of the above noted vehicle with a request to start a specific case against him U/S 285/286/188/120B IPC & Sec 24/26 of West Bengal Fire Service Act and arrange for its investigation.
