

PETITION OF COMPLAINANT U/S 156(2) ur. pe.

The complainant begs to state as follows:

1) That the complainant is the married wife of accused No. 1 and their marriage was solemnized on 14/12/2021 according to Special Marriage Act before the marriage officer and thereafter all Hindu rites and customs were performed on the same day. The marriage was negotiation one.





- 2) That the accused No. 1 is the husband, accused No. 2 & 3 are parents -in-law, accused No. 4,5,6 are married sister -in-law, accused No. 7, 8 & 11 are cousin brother-in-law of the complainant and accused No. 9 is the daughter of accused No. 7 and accused No. 10 is aunt-in-law of the complainant.
 - "Gandha Banik" caste and it is the customs of the said caste to give huge gold ornaments at the time of their daughter marriage. Accordingly at the time of daughter's marriage the parents of the complainant and relatives gave huge gold ornaments weighing more or less 35 bhories to the complainant and the parents of the complainant also gave huge gold ornaments to the accused No. 1 including Gold wrist watch worth of Rs. 5,00,000/- as per demand of accused persons.
 - That after marriage the complainant went to the house of accused person with accused No. 1 taking all her stridhan articles with a view to live there with the accused No. 1 as husband and wife. Just after reaching in the matrimonial home, the parents in-laws of the complainant i.e. accused No. 2 and 3 and sister-in-law i.e. accused No. 4, 5, 6 took all the gold ornaments of the complainant from the custody of the complainant to their custody with a plea of safety and security so, the complainant being newly married wife believing them entrusted all her articles and ornaments to them.

- 5) That after reaching in the matrimonial home the complainant noticed that husband of the complainant is a puppet of his parents, sister and cousin brother i.e. accused No. 7, 8 and their mother i.e. accused No. 10.
- (b) That at the night of Fulsajya the accused No. 1 came to his room in a drunken condition at about 3 a.m. and being asked by the complainant he replied that he was busy with his elder sister as she was in bad mood. Hearing this the complainant became frustrated that in the night of Fulsajya can any newly married young boy came his room at 03:00 a.m. night. Moreover after entering into room the accused No. 1 ordered the complainant to make ready wine for him and also for complainant. The complainant protested but the accused No. 1 replied that the complainant must take wine with him as it is the culture of their family and they also took alcohol with all their family members.
 - 7) That after few days of marriage the complainant was subjected to utmost cruelty both physical and mental by all accused persons. The married sister-in-laws more or less every day instructed their mother i.e. accused No. 2 and the accused No. 3 used to tease complainant implicating her parents and their culture.
 - B) That accused No. 1 every night used to came late at night and compelled the complainant to prepare wine peg for him and when the complainant protested she was subjected to Physical assault by him. That complainant narrated those incident to accused No. 2 & 3 i.e. parents –in-laws but they rebuked her by saying "পুরুষ মানুষ মদ খাবে না , মেয়েছেলের বাড়ি যাবে না তো বাড়িতে কি বউ এর আঁচল ধরে বসে থাকবে"





- That the husband of the complainant every day wake up from sleep at 1/1-30 p.m. (Noon) and thereafter he went to his business place which is his family business and the said business mainly look after by the cousin brother -in-law of the complainant namely Rana and Raja Chandra. They used to supply money to the accused No. 1.
- That the complainant was not allowed to talk with anybody even she was not permitted to open window of her room. Practically she was not even permitted to talk with any of her neighbors and distance relatives.
- That occasionally the family members of at matrimonial house of the complainant arrange get-together programme in their residence and all the family members used to take alcohol and complainant was compelled to serve food, snacks drinks to them and also compelled to wash their dish, glass etc. which was used by those persons.
- the complainant and the mother-in-law of the complainant openly declared that his son shall not share bed with the complainant and accused No. 10 namely Suman Das who use to put his nose in every matter and also instigate the accused No. 1 and his parents to inflict torture upon the complainant. The accused No. 10 also said the complainant that as her husband did not share bed so he is ready to share bed with complainant.

- That once the complainant was fallen ill for urine 13) infection but the accused persons neither took her any doctor nor provide any treatment towards the complainant rather the accused persons told that let the complainant die so they could give their son's marriage further.
- That prior to marriage the father of the complainant fixed a sum of Rs. 3,70,000/- in the name of complainant but after marriage she was compelled to transfer the same with the joint name with her husband but after few months the accused No. 1 liquidate the said Rs. 3,70,000/- without the consent, knowledge of the complainant.
- That on 09/03/2022 the husband of the complainant 151 and her all in-laws informed her that her grandmother seriously ill for which she wants to see her. Being heard she was morrows but her in-laws assured her that they definitely arrange to send her. On that very day the husband of the complainant taken her and started for the paternal house of the complainant by car but surprisingly the accused No. 1 taken the complainant at the house of his younger sister at Dumdum, Where the complainant found that Suman Das and Kakoli Das already reached there. Then the complainant understand that it was a conspiracy which made by all family members of her in-laws to drive her out from their house.
- That after some times of reaching at Dumdum the 101 husband, Suman Das, Kakoli Das, Rupa Dey forced to leave her sister-in-laws flat and bring her in road, it was about 12:30 a.m. (night) then the accused persons direct her that they informed her parents who may coming soon and saying this they fled away from the said place by the car





leaving her alone in road at midnight. After some time the parents of the complainant came there and rescued her from road. Since then the accused persons did not take any information of the complainant.

- That on 12th May 2022 the complainant along with her parents and relatives went to her matrimonial home for reconcile the matter but the accused persons declined to talk with them, Then complainant demanded her gold ornaments and articles from accused persons at this they became furious and drive them out from their house and the accused persons threatened them that they will not give any ornaments and articles to the complainant and if the complainant further tried to take entry into their house then she will face dire consequences.
- That the accused persons forcefully and illegally retain all the stridhan articles of the complainant and they using those articles as their own.
- 19) That the complainant informed the entire incident to the I.C. Purulia Town P.S. and also S.P. Purulia through Regd. Post with A/D but no action has yet been taken by the Police authority so she compelled to files this petition before the I.d. Court.

In this circumstances it is prayed that your Honour may be pleased to allow this petition and send it to I.C. Purulia Town Police Station for investigation treating the same as FIR U/S 156(3)Cr.P.C.
