Sub: Prayer for lodging F.I.R. against arrested accused person Kamal Bauri (34 yrs) S/O- Lt. Bimal Bauri of Sinderpatti, Near Mansha Mandir, Ward No-10, PS- Purulia (T), Dist- Purulia

In producing herewith one arrested accused person namely Kamal Bauri (34 yrs) S/O- Lt. Bimal Bauri of Sinderpatti, Near Mansha Mandir, Ward No-10, PS- Purulia (T), Dist- Purulia under arrest alongwith following seized articles under proper seizure list and being labeled properly:-

(1) 25 (Twenty five) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80° UP and MRP is Rs 55/- being sealed properly) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149.

(2) Out of 25 (Twenty five) bottles 01(one) bottle is kept as sample.

I, Gouri Charan Mahadani, beg to report that while I was performing Evening mobile duty vide Purulia (T) PS GDE No- 1674 dated 28.09.22, at about 19:45 hrs received a secret telephonic information from source that one person namely Kamal Bauri (34 yrs) S/O- Lt. Bimal Bauri of Sinderpatti, Near Mansha Mandir, Ward No-10, PS- Purulia (T), Dist- Purulia is selling country spirit illegally at a higher price causing unlawful gain to him by unlawful loss to the purchasers from his dwelling house. .

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of C/236 Ram Chandra Garai and C/154 Rajib Nag all of Purulia (T) PS proceeded to work out the information.

At 20:05 hrs. we reached at Sinderpatti, Near Mansha Mandir, keeping our Govt. vehicle at a reasonable distance we proceeded towards Sinderpatti as shown by the source from the distance and found that the said person was selling Country Spirit as noted above to some persons and some persons were found drinking there. Seeing the police, all of them tried to flee away leaving some plastic glasses at the spot. On hot chase one of them could be nabbed. On interrogation he confessed his guilt as he was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. He also failed to produce any license in favour of selling, keeping or possessing Country Spirit and the said person disclosed his identity as noted above. On search of the house we found 25 (Twenty five) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80° UP) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149. As such at about 20:15 hrs to 20:35 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and seal properly. I also took samples and arrested him at 20:45 hours observing all the formalities as the said person committed an offence which attracts sec. 46 (A) (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
