

The complainant most respectfully sheweth: -

1. That the complainant is a permanent resident of vill:Lachhmanpur under Raghunathpur P.S., Dist: Purulia(W.B) within
the local limit of Ld. court. Be it noted accede are full coresident of complainant, complainant is a santal adibasi at
original and belongs schedule tribe category.

2. That Baidyanath Majhi \$\forall Lt. Sambhunath Majhi and Jyotilal Majhi \$\forall O Sambhunath Majhi were two full brothers and were the lawfull exclusive owner of piece of land within mouza: Lachhman pur, pertaining to J.L. NO: 173/153 C.S. Plot no: -899 corresponding to R.S. Plot no: -862 total area: 1.03acre out of it 11 dec. in the southern portion. Be it noted on demise of the said owners complainant came into the possession over the said piece of land having valid right, title, therein and has been possessing the same to the full knowledge of the local gentrie -s.

3. That the complainant submits that Sambhunath Majhi and jyoti lal Majhi purchesed the said piece of land within R.S. Plot no 862 from previous owners namely Gyanendranath Mukherjee and some others of vill:- Brindabanpur within P.S. Santuri, Dist:- Purulia (W.B)

4. That on 08-09-21 the accd. Bhajahari Gorai S/O Chaitannya Gorai came to the aforesaid property of complainant and tried to take forcible possession of the same in which complainant raised protest whereupon the accd. Bhajahari Gorai and his son gave out threat disciosing "A JOMI AMAR.

5. That it is submitted the accd. persons for illegal gain temperature allegedly the deed no: 203 dtd: 1971.

6. That surprising to note the accd. persons in fulfilling their recommon intention after hatching conspiracy fradulently filed Deed NO:-203/1971 before the concerning authority for getting his name recorded in the aforesaid plot denying complanant's title & possession thereon.

7. That the complainant collected the Xerox copy of sale deed no: 203/1971 wherefrom it appears that R.S. Plot no: -862 of mouza: Lachhmanpur has been fradulently super imposed after deleting the actual plot with a view to illegal gain. Be it noted on 08-09-21 accd. Bhajahari Gorai and his son should the original deed of that alleged Xerox copy wherefrom it clearly transpired that actual plot number was tempered and R.S. Plot plot 862 has been superimposed and when complainant challenge claiming the plot in original deed as superimposed after tempering accd. persons shouted to complainant "MAJHI CHOTOLOK TUI BESI PONDIT. TUI LEKHAPORA JANIS JE ETA BUJEI".

Shat complainant also obtained the certified copy of Deed no:-203/1971 wherefrom it is depicted that vendors of that Deed Askutosh Mukherjee and others have executed a Regd. Sale deed being no:-203/1971 in favour of Accd. Jamunabala Dasi on dtd:-11-01-1971 in respect of R. S. Plot no:-659 corre sponding to C. S. Plot no:-932 of mouza: achhmanpur for an area 16dec. classifide as Baid. Needless to say in the said certified copy of alleged deed no:-203/1971 if there is any smell of R. S. Plot no:-862 rather in the original (Hempered) deed sold area has been shown larger as 35dec. but in the certified copy of alleged deed no:-203/71 sold area within R. S. Plot no:-659 has been actually written as 16dec.

9. That on the strength of alleged tempered deed all the accd persons have fradulently got recorded their name of accd. persons-1 in the L.R.Khatian vide no:593 for an area of 35 dec. under active aid and support as well as Mis-representation of the accd. person no:2 & 3

10. That due to such illegal act and fradulent and forged document and by practicing fraud representing as lawfull owner accd. person no:01 alongwith acced. no:2 & 3 who knowing all events persuaded and afated the accd. person no:01 to do such illegal act by getting done the L.R. record in the name of Jamunabala Dasi @ Gorai W/O Chaitannya Gorai.

11. That due to such illegal act and wrongful gaining of L.R. Khatian no:593 of mouza: Lachhmanpur complainant has been deprived from getting his name recorded or published in sepa rate L.R. Khatian by competent P.L.& L.R.O. the accd. persons have comtted everything with a view to grab the property of the complainant, who belongs to sch. tribe category.

12. That from the foregoing paras it is crystal clear that the accd. persons have committed the offence as attributable U/S S.C. & S.T. prevention of atrocity act. and other sections as cited above.

13. That the complainant in order to book the accd. persons in criminal in case owing to their illegal act submitted his grievances to the I/C Raghunathpur P.S. on in writing who initially assured the complainant to look into the matter but invain. Therefore the complainant sent his grievances to the S.P. Purulia but no effective measure has been taken. Thus finding no other alternative the complainant seeks his remedy before the Ld. court.

Therefore on the set forth ground petitioner/
complainant prays before the Ld. court to pass necessary
order upon I/C Raghunathput to immediate investigate
the case treating the instant petition as an F.I.R.
U/S 156(3)Cr.P.C.
