Sub: Prayer for lodging FIR against arrested accused person namely Nibhajan @ Niranjan Bauri (30) S/o Mangal Bauri of Raghunathpur, Ward No 1, PS - Raghunathpur, Dist.- Purulia.

Sir,

In producing herewith the arrested accused person namely Nibhajan @ Niranjan Bauri (30) S/o Mangal Bauri of Raghunathpur, Ward No 1, PS - Raghunathpur, Dist.- Purulia along with seized one Black & Yellow colour Auto - Rickshaw bearing Reg. No. WB 55/6360.

I beg to report that today (17.09.2022) myself SI Biswajit Sarkar along with C/685 Dilip Chhatait and C/716 Achintya Majee both of Raghunathpur PS, Dist.- Purulia including evening mobile officer & force were performing special Naka Checking duty at Munsefdanga near Durgamandir on Purulia - Barakar Road vide Raghunathpur PS CC No. 2845/22 dated- 17.09.2022. At about 18:05 hrs. I found one Auto Rickshaw was coming with heavy speed from Raghunathpur Traffic more side towards Asansol side rashly and negligently. We were tried to stop the said Auto - Rickshaw driver but he was trying to escape from the Naka point so rashly, there was every possibility of loss / serious injury of nearby public or passenger of the said Auto - Rickshaw due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I seized the Auto - Rickshaw with a view to prosecute him U/S 279 IPC and 184 M.V. Act 1988 in presence of police party and one passenger duly signed by them. The whole process of seizure was completed in between 18:15 hrs to 18:25 hrs. I also arrested him as he violated Sec. 279 IPC and 184 M.V. Act 1988 at 18:35 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 184 M.V. Act 1988 may kindly be initiated against accused Nibhajan @ Niranjan Bauri (30) S/o Mangal Bauri of Raghunathpur, Ward No 1, PS - Raghunathpur, Dist.- Purulia and arrange it's investigation.
