F.I.R. against the tractor (WB 55 A 9555) carrying white stone, without any proper challan, at Nutandih area (Barakar Road)

The photocopy of the backdated challan (PUR/86/280920/564/1001626): 1 Page;

The photocopy of the self declaration, made by Prakash Majee: 1 Page

A tractor (WB55 A 9555) was caught by the raid team, carrying white stones, during the afternoon period, at around 04.15PM, without any proper challan, at Nutandih area (Barakar Road).

However, while being brought to the Police Station, the driver showed a challan (PUR/86/280920/564/1001626; Date: 04/09/2022; Hologram No. 003248002; Sukriti Pebbles; Black Stone; Name of Purchaser: Rajbir Construction Pvt Ltd; Vehicle No. WB 812103), where, the date of challan did not match with the date of carrying the stone, the vehicle number too did not match, and moreover, the challan was about the Black Stone, whereas, the tractor WB55 A 9555 was carrying the White Stone, fully loaded in the said tractor (Annexure: I).

Meanwhile, one Prakash Majee came to the Office of the BL&LRO, Raghunathpur - I, Purulia, claiming the ownership of the said tractor, and submitted a self-declaration (Receipt No. 5247; 28/09/2022), confessing, that, the tractor was carrying white stones, on behalf of Rajbir Construction Pvt Ltd, which may somehow be helpful in this regard (Annexure: II).

The undersigned did not verify the statement, provided by that Prakash Majee.

In this context, the Block Land & Land Reforms Officer, Raghunathpur - I, Purulia requests your good Office, to accept this letter as an FIR against that said tractor (WB 55 A 9555) U/S 379 of Indian Penal Code, as well as, U/S 21 MM(DR) Act, 1957.

The key and the tractor (WB 55 A 9555), full of white stones are being hereby handed over to you, as the seized items.
