Sir,

In producing here with approx 06 MT Steam Coal along with Electric Iron Weight Machine, one white colour Scorpio bearing No. WB 54Q/6913, 04 (Four) motorcycle bearing No. WB 82C/5355 (Black & Red Colour Hero Super Splendor), WB 82C/6471 (White colour TVS Jupiter), WB 56B/7457 (Black colour Hero Honda Street), WB 38AK/6370 (Red & White colour Hero Splendor) under proper seizure list with sample 1 KG from seized Steam Coal, I beg to submit that on 23/03/2022 myself SI Indrajit Sarkar along with force C/1274 Ganesh Ch. Saha, C/600 Amit Shit, C/682 Mahadeb Rajak vide Raghunathpur PS CC No. 2901/22 were engaged in night mobile duty at Raghunathpur PS area with Govt. Vehicle No. WB24AE/0570. At about 12:45 hrs when we were at Chinpina side received a tip off information that some miscreants namely (1) Shibnath Karmakar S/o Late Magaram Karmakar of Nanduara, Ward No 12, PS – Raghunathpur, Dist.- Purulia, (2) Sarfaraj Ahamad @ Raju S/o Hamja Ali of Bankura Road, Ward No 1, PS – Raghunathpur, Dist.- Purulia and 04 others motor vehicles owner stocked a large quantity of steam coal in abandoned place far away from Raghunathpur – Bankura Road near at Lohar Pool Bricks Field, Raghunathpur for transporting the same in a clandestine manner forming a racket. After getting information myself along with my accompanying forces rushed to the anticipated place with an intimation to my superior and as per direction we reached at near the above noted place at 12:55 hrs. and found the above noted vehicle and motorcycles parked there from a distance. I would like to note here that on way I have tried to collect local witnesses from the nearby villages but found no populated area nears the 500 Mtrs. of the PO. On seeing the Police Party from a distance the above noted some miscreants have fled away ~~way~~ from the spot leaving the above noted four wheeler and motorcycles and they could manage to escape despite our utmost efforts. On verification we found that approx 06 MT Steam Coal were stocked for illegal coal for clandestine business by wrongful gains.

On secret enquiry through my reliable source it came out that the present owner of the vehicle namely Shibnath Karmakar S/o Late Magaram Karmakar of Nanduara, Ward No 12, PS – Raghunathpur, Dist.- Purulia and accompanied by Sarfaraj Ahamad @ Raju S/o Hamja Ali of Bankura Road, Ward No 1, PS – Raghunathpur, Dist.- Purulia and 04 others motor vehicles owner with their full knowledge and consent illegally stocking Steam Coal for clandestine business after forming a racket and also procuring the Steam Coal by theft or any dishonest means from illegal mines/ pits with a view to dispose off the same by transporting the Coal for their wrongful gain by causing a loss of National property.

So, I seized approx 06 MT Steam Coal along with Electric Iron Weight Machine, one white colour Scorpio bearing No. WB 54Q/6913, 04 (Four) motorcycle bearing No. WB 82C/5355 (Black & Red Colour Hero Super Splendor), WB 82C/6471 (White colour TVS Jupiter), WB 56B/7457 (Black colour Hero Honda Street), WB 38AK/6370 (Red & White colour Hero Splendor) after preparing a proper seizure list duly signed by my accompanying forces and brought to PS. I have also collected sample 1 KG from the seized Steam Coal.

Hence, on returned to PS with the above noted seized vehicle including motorcycle, Electric Iron Weight Machine and approx 06 MT Steam Coal with 01 KG sample Steam Coal, I do here by lodge this complain with a prayer that a specific case may kindly be started against (1) Shibnath Karmakar S/o Late Magaram Karmakar of Nanduara, Ward No 12, PS – Raghunathpur, Dist.- Purulia, (2) Sarfaraj Ahamad @ Raju S/o Hamja Ali of Bankura Road, Ward No 1, PS – Raghunathpur, Dist.- Purulia and 04 others motor vehicles owner under proper section of law and also arranging for its investigation.
