I am Amlesh Singh , S/O Surendra Singh, Address- Sarweshri Nagar Itki Road Ranchi, Ward No. 36, House No. - 03, PS - Sukhdeo Nagar, Dist.- Ranchi, Jharkhand. I am working as a Project Manager at Singh Infratel Pvt. Ltd., West Bengal having office address at Harmu Housing Colony, D-21, Harmu Ranchi, Jharkhand at Airtel OFC UG Project Work. In our different location we took stores as rent house for keeping our project related goods and in course of that, we have hired one campus as our store at Paharigora more, PS - Santaldih, whose owner is one Sukumar Tewary, S/O Fatik Tewary of Vill. - Asurbandh, PS - Santaldih, Dist.- Purulia and it is functioning since last two years.

On 03.09.2022 at about 16.30 hrs, I received a phone call from above noted Sukumar Tewary that one driver namely Goutam Ravidas of vehicle having registration no. - JH 02 0659, came and took some materials i.e. 2KM duct (colour - orange, Airtel/Telesonic, Silicore Duct 40/34MM, 4X500mtrs each) in the name of one Sanjay Jha, Supervisor of our company from the above noted store. On its confirmation I totally denied it as neither I nor any representative of my company sends anybody to take the articles. Hence, the above noted Sukumar Tewary commits criminal breach of trust on us. Some other persons may involve in this case. The total value of the article is Rs. - 1,50,000/- (One Lakh Fifty Thousand) approx.

Hence, I pray before you to register a case at your PS and arrange the recovery of the above noted articles. Hope, your good office will be kind enough in providing the requisite and resolve the issue.
