With due respect I PSI Mrinmay Bhakta, beg to submit before you that on 27/09/2022 at about 14:25 hrs while myself along with force were performing mobile duty vide Santuri PS CC No-3697/22 Dated-27/09/2022 at Hansdima More on Raghunathpur-Saltora Road (SH-8). I found one Motorcycle was coming from Saltora side towards Santuri side with driving at excessive speed. Police personnel, present their in proper Police uniform raised hand and directed him to stop the Motorcycle but the said Motorcycle, violating the Police Signal and endangering human life by rash and negligently driving the Motorcycle which may cause accident to the road user any time. After long chase we can able to apprehend him at Dhekshila More. On interrogation he made incoherent statement at different time. He disclosed his identity as Mansaram Besra (24 Yrs) S/o- Suplal Besra of Vill- Amjore, PO-Tiluri, PS-Saltora, Dist-Bankura. On being asked he failed to produce any valid documents of the said Motorcycle.

Hence he violated the provision of Section 279 IPC. So, I seized the Motorcycle having Regd. No- WB68AC/7148 at 14:45 hrs to 14:55 hrs under proper seizure list duly singed by the witnesses and arrested the offending driver namely Mansaram Besra (24 Yrs) S/o- Suplal Besra of Vill- Amjore, PO-Tiluri, PS-Saltora, Dist-Bankura at 15:05 hrs avoiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court. As the offence is bailable, hence the accused driver namely Mansaram Besra was released on bail after furnishing proper bail bond.

So I pray before you that a specific case may kindly be registered against the accused driver namely Mansaram Besra (24 Yrs) S/o- Suplal Besra of Vill- Amjore, PO-Tiluri, PS-Saltora, Dist-Bankura of Motorcycle having Regd. No- WB68AC/7148 for committing offence U/S-279 IPC.
