Prayer for starting a specific case against Akash Chatterjee (19 Yrs), S/O- Pradyut Chatterjee of Sub: Vill- Ramchandrapur, PS-santuri, Dist-Purulia and Sourav Auddya (18 Yrs), S/O Rajendranath Auddya, Vill. Bartoria, PS- Neturia, Dist.- Purulia.

Respected Sir,

In producing herewith arrested accd persons Akash Chatterjee (19 Yrs), S/O- Pradyut Chatterjee of Vill- Ramchandrapur, PS-santuri, Dist-Purulia and Sourav Auddya (18 Yrs), S/O Rajendranath Auddya, Vill. Bartoria, PS- Neturia, Dist.- Purulia and one charred motorcycle under seizure list.

I would like to draw your attention that today (27/09/2022) I was performing mobile duty at PS area. At around 17:45 hrs I received a telephonic information from a local person of Ramchandrapur that two youths were assaulting each other with the issue best known to themselves. I informed the matter to you over telephone and as per your direction I shall along with accompany force started for the spot.

At around 18:25hrs I reached at Ramchandrapur Ananda Mela Ground, Vill.- Ramchandrapur, PS- Santuri, Dist.- Purulia and found that a motorcycle was burning and two youths were standing there and abusing each other with filthy language and in front of us they were scuffling. We detained them and extinguished the fire. On interrogation they revealed their identity as Akash Chatterjee (19 Yrs), S/O-Pradyut Chatterjee of Vill- Ramchandrapur, PS-santuri, Dist-Purulia and Sourav Auddya (18 Yrs), S/O Rajendranath Auddya, Vill. Bartoria, PS- Neturia, Dist.- Purulia and they could not produce any identical age proof and also confessed that they met together there to settle up an old issue and when it was not settle up both of them got angry and started to assault each other with fist and blow. Suddenly Akash Chatterjee (19 Yrs), S/O- Pradyut Chatterjee of Vill- Ramchandrapur, PS-santuri, Dist-Purulia set fire on the motorcycle of Sourav Auddya (18 Yrs), S/O Rajendranath Auddya, Vill. Bartoria, PS- Neturia, Dist.-Purulia and the motorcycle was totally burnt. Accordingly I seized the motorcycle from there and arrested both Akash Chatterjee (19 Yrs), S/O- Pradyut Chatterjee of Vill- Ramchandrapur, PS-santuri, Dist-Purulia and Sourav Auddya (18 Yrs), S/O Rajendranath Auddya, Vill. Bartoria, PS- Neturia, Dist.-Purulia. During local enquiry it was also learnt that some local person try to stop them but both the accd persons did not pay any attention to their words.

So I would like to request you to lodge a specific case under proper section of law and arrange for its investigation.
