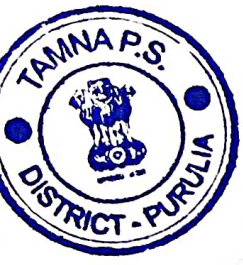

In producing herewith arrested offending driver namely Ganesh Ghosh (50 Yrs) S/o- Prasun Kanti Ghosh of Dulmi, near Durga Mandir, PS- Purulia (T), Dist- Purulia along with one seized black colour Honda Shine Motor Cycle bearing Registration No- WB56F/1581.

I, Hemanta Kr. Sahababu S/o- Lt. Madan Mohan Sahababu of Vill- Jabarra, P.O- Jhapra, PS- Para, Dist- Purulia, SI of Police, PS Tamna, Dist- Purulia beg to report that today myself along with C/2671 Prasanta Rajak and NVF/0151 Rajib Kr. Mahato all are of Tamna PS were performing spl. mobile duty at Tamna PS area vide Tamna PS GDE No- 300 Dtd- 07.09.2022 at about 17:15 hrs. at near Tamna PS Kali mandir, under Tamna PS, I found one black colour Honda Shine Motor Cycle bearing Registration No- WB56F/1581 was coming from Chakaltore side rashly and negligently. We try to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop at near Tamna PS Kali mandir, under Tamna PS, Dist- Purulia. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested the above noted person of arrest after disclosing the ground of his arrest and also observing all legal formalities regarding arrest as he violated Sec. 279 IPC. I also seized the black colour Honda Shine Motor Cycle bearing Registration No- WB56F/1581 in presence of witnesses and informed him and his family member regarding the ground of arrest.

Therefore, I pray that a specific case may kindly be started against the aforesaid driver namely Ganesh Ghosh (50 Yrs) S/o- Prasun Kanti Ghosh of Dulmi, near Durga Mandir, PS- Purulia (T), Dist- Purulia.


