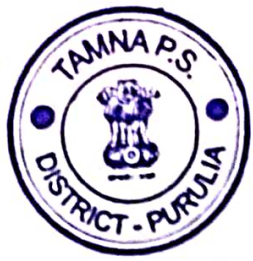

In producing herewith arrested offending driver namely Akram Ansari (26 Yrs) S/o- Kurban Ansari of Vill- Barman Bahiyon, P.O- Badbara, PS- Bengabad, Dist- Giridih, Jharkhand along with one seized vehicle (Truck) bearing Registration No- WB19J/3299.

I, Chittaranjan Mukhopadhyay S/o- Abhay Charan Mukhopadhyay of Vill+P.O- Lagda, PS- Purulia (M), Dist- Purulia, ASI of Police, PS Tamna, Dist- Purulia beg to report that today myself along with C/1509 Animesh Mukherjee and C/1336 Madhusudan Paramanik all are of Tamna PS were performing a crime day mobile duty at Tamna PS area vide Tamna PS GDE No- 633 Dtd- 15.09.2022. Received information at 15:15 hrs that one Truck having Registration No- WB19J/3299 was coming from Simulia side towards Belguma side after damaged one electric pole near at Pragati Cement factory on Willcox road. My self along with force reached near Belguma Police Line and found the said Truck bearing Registration No- WB19J/3299 was coming from Simulia side rashly and negligently. We try to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop at near Belguma Police Line, under Tamna PS, Dist- Purulia at about 15:30 hrs. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested the above noted person after disclosing the ground of his arrest and also observing all legal formalities regarding arrest. I also seized vehicle (Truck) bearing Registration No- WB19J/3299 in presence of witnesses.

Therefore, I pray that a specific case may kindly be started against the aforesaid driver namely Akram Ansari (26 Yrs) S/o- Kurban Ansari of Vill- Barman Bahiyon, P.O- Badbara, PS- Bengabad, Dist- Giridih, Jharkhand.
