In producing herewith arrested offending driver namely Sibuh Mahato (28 Yrs) S/o- Lt. Iswar Mahato of Vill- Pichasi, PS- Tamna, Dist- Purulia along with one seized vehicle (Tata Ace) bearing Registration No- WB55A/0140, Engine No- 275IDI06DXYS85409 & Chassis No- MAT445056CZD37552.

I, Goutam Kr. Bangal S/o- Bangshi Bangal of Vill- Pratapbagan, Prantika, P.O + PS- Bankura (S), Dist- Bankura SI of Police, PS- Tamna, Dist- Purulia beg to report that today myself along with NVF/0151 Rajib Mahato and HG/1577 Badal Mahato all are of Tamna PS were performing evening mobile duty at Tamna PS area vide Tamna PS GDE No- 788 Dtd- 18.09.2022. At about 18:35 hrs. near at Chandradih Nagar more, under Tamna PS, we found one white colour Tata Ace having Registration No- WB55A/0140 was coming from Chakaltore side towards Purulia side on Purulia Manbazar road rashly and negligently. We try to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop at near Chandradih Nagar more, under Tamna PS, Dist- Purulia. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested the above noted person after disclosing the ground of his arrest and also observing all legal formalities regarding arrest. I also seized vehicle (Tata Ace) bearing Registration No- WB55A/0140, Engine No- 275IDI06DXYS85409 & Chassis No- MAT445056CZD37552 in presence of witnesses.

Therefore, I pray that a specific case may kindly be started against the aforesaid driver namely Sibuh Mahato (28 Yrs) S/o- Lt. Iswar Mahato of Vill- Pichasi, PS- Tamna, Dist- Purulia.
