I, Badal Paramanik S/o- Lt. Nirmal Paramanik of Vill+P.O- Biltora, PS- Purulia (M), Dist- Purulia, SI of Police of Tamna PS, Dist- Purulia along with force return to PS and brought seized one Blue colour DI 734 Sonalika Tractor having Registration No- WB55B/4312, Engine No-3100NS04K993038F31 & Chassis No- BZQSR998808SM attached with trolley loaded with sand approx. 100 cft. and lodged this complaint to the effect that today i.e on 20.09.2022, myself along with force i) C/3003 Tapas Duley and ii) HG/1903 Haripada Tudu were performing PS area mobile duty vide Tamna PS GDE No- 875 date- 20.09.2022. During my mobile duty at about 17:25 hrs received credible source information that one Blue colour Tractor is carrying sand illegally from Baligara Sand ghat and going towards Purulia side. Accordingly, myself along with force left to work out the said source information. Then, we intercepted the aforesaid tractor near at Sonaijuri more under Tamna PS, Dist-Purulia at about 17:45 hrs and found that the above noted tractor was tagged with a trolley loaded with sand (approx. 100 cft.). But seeing the Police party, driver of the tractor fled away leaving the said tractor at Sonaijuri village under Tamna PS. We tried to apprehend them but failed. So, there is every reason to belief that the owner and driver of above noted tractor dealing in sand business in clandestine manner. Bring the Tractor at PS after arranging driver from our force.

On return to Tamna PS, kept the aforesaid seized tractor attached with sand loaded (Approx 100 cft.) trolley at PS compound and I do hereby submit written complaint before you to start a cog case against the owner and driver of the tractor having Registration No- WB55B/4312, Engine No-3100NS04K993038F31 & Chassis No- BZQSR998808SM under proper section of law.
