Respected Sir,

I, Hemanta Kr. Sahababu S/O- Lt. Madan Mohan Sahababu of Vill- Jabarrah, P.O- Jhapra, PS- Para, Dist- Purulia, SI of Police, of Tamna PS producing herewith one arrested accused person namely Ujjwal Gope (22 yrs) S/O- Sisupal Gope of Vill- Shyampur, P.O- Nadiyara, P.S- Purulia (M), Dist.- Purulia with seized articles i.e. 1) One white colour plastic jarican containing Approx 09 Ltrs. ID Liquor, 2) 06 pcs plastic glasses (3) Approx 1 Ltr. ID liquor as sample which was collected from seized articles from SI No-01 & kept in a plastic bottle which were seized under proper seizure list.

I beg to submit that today (28.09.2022) during PS mobile duty acting of a secret source information myself along with i) C/2671 Prasanta Rajak & ii) HG/1948 Iswar Mahato both of Tamna PS conducted raid in the vegetable shop of accused person Ujjwal Gope on Purulia-Ranchi road near Sainik School under Tamna PS at about 18:15 hrs and found that he was keeping and selling of ID liquor at his shop (Vegetable Shop) to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) One white colour plastic jarican containing Approx 09 Ltrs. ID Liquor, 2) 06 pcs plastic glasses, (3) Approx 1 Ltr. ID liquor as sample which was collected from seized articles from SI No-01 & kept in a plastic bottle which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Ujjwal Gope (22 yrs) S/O- Sisupal Gope of Vill- Shyampur, P.O- Nadiyara, P.S- Purulia (M), Dist.- Purulia as per proper section of law.
