Sir,

In producing herewith arrested accused person namely Rajesh Majhi (35 yrs)
S/O Lankeswar Majhi of Vill-Dhabari, P.S- Adra, Dist- Purulia along with seized
articles (1) One Maruti Suzuki Omni Blue Blaze colored Maruti van bearing reg. No
WB82C/1682.

I beg to report that today myself along with C/522 Ruplal Tudu, C/1290 Kuntal
Nandi were engage in day mobile duty and performing NAKA duty at Adra- Kashipur
Pitch road near Roguri Village More under Adra PS vide Adra PS GDE No-224 date
07.10.2022 and Adra PS C.C No-3055/22 dtd.07/10/2022. During Naka duty at about
13:05 hrs. I found one Maruti Suzuki Omni Blue Blaze colored Maruti van bearing reg.
No WB82C/1682 coming from Kashipur side towards Adra side rashly and
negligently. We try to stop him but the driver of the said maruti van named in above
was trying to escape the place so rashly, there was every possibility of loss/ serious
injury of nearby public due to his such driving. After a hot chase we could able to stop
him. On being asked, he stated his name and address as noted above, but unable to give
any satisfactory account for his such rush and negligent driving which may cause
endanger to human life.

So, I arrested him as he violated sec 279 IPC and 184 MV Act 1988 at 13:37 hrs.
I also seized the Maruti Van with a view to prosecute him U/S 279 IPC and 184 MV
Act 1988 in presence of local witnesses and police party. The whole process of seizure
was completed in between 13:15 hrs to 13:35 hrs. His family member was also
informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 184 MV Act 1988 may kindly
be initiated against accused Rajesh Majhi (35 yrs) S/O Lankeswar Majhi of Vill-
Dhabari, P.S- Adra, Dist- Purulia.
