This is to inform you that I Bundo Baur daughter of dt. Lawrence Baur and Beverden Baur at present living in Jayadhi Adra came for my puja vacation and permanently living at Buxidha has been receiving threats, calls, abuse of language and being followed every where, whenever I put my foot out of the house by Mr. Pawan Khan. This Mr. Pawan Khan had taken me away from my parents when I was around 14 year old and forced me to get married and live with him by threatening me to put end to my younger siblings in the year 2015 he married me by his customs. I lived in Adra Jaldanga for 1 1/2 years and then lived in Ranchi, JH for 2 1/2 years. In the year 2019, I had given birth to a baby boy named Rajan aged about 2 1/2 years. On getting a chance to meet my grandfather I was able to escape with my son back to my grandfather's house after all his torture. After meeting my family being in their safe hands I have decided to never to see his face again. On 4th August 2022 my grand uncle was very serious at Adra Railway hospital. When my grandfather left to shift my uncle to Durgapur this same Mr. Pawan Khan son of Mr. Lokim living in Jaldanga Adra took the advantage taking me along and snatched my son from after him to get back my son, knowing he was along with two other men who could not recognize them in the dark. He beat me taking help of the two other men and tried to strangulate me. Thanks to the local people who were passing on the road rescued my life and my child from him.

It has been six months that I have left him. Being a teacher at Puvulia I used to do up and down but he came in the train and threatened that he will murder me, push me down from the train or would throw acid on my face for that I have to leave Adra and go to Puvulia to live.

Recently we have come to Adra for puja vacation, to Jayadhi but here threats have started again from last night. He is coming again throwing stones at our gate, honking on someone's bike abusing us to tapping our door and asking to open up the gates.

This morning I went to the thana to save from him but the moment I came back he was standing at our main gate with a local man saying that if I step to the thana again he would disfigure me, cut my son into pieces and murder my grandfather.

Sir, stepping out in Adra is become unsafe for me and my mother's family we have no such man power to protect us from him and I do not want to live anymore with him so I request you to kindly look into the case and take action. Just for reference my kidnapping case has been filed in Adra thana in the year 2015 also he harasses for money all the time and for every thing.
