This is to inform you that S. Brenda Dourz daughter of Mr. Jerome Dourz and Reverleen Dourz at present living in Nagpur his abducker came for my <sup>short</sup> ~~short~~ <sup>short</sup> ~~short~~ <sup>short</sup> vacation and permanently living at Puriya has been receiving threats, calls, abuse of language and being followed every where, whenever I put my foot out of the house by Mr. Rizwan Khan. This Mr. Rizwan Khan had taken me away from my parents when I was around 11 years old and forced me to get married and live with him by threatening me to fire and end to my younger sibling. In the year 2015 he married me by his customs. I lived in Abra Salangar for 11/2 years and then moved in Ranchi, JH for 2/1/2 years. In the year 2019, I had given birth to a baby boy named Parjan aged about 2 1/2 years. On getting a chance to meet my grand-father I was able to escape with my son back to my grandfather's house after all this torture. After meeting my family being in their safe hands I have decided to never see his face again. On 18.15 hrs and 9th August 2022 my grand-uncle was very serious at Abra started from Railway hospital. Within my grandfather left the shift my 105/22 dt- Uncle to Dungarpur this same Mr. Rizwan Khan son of Mr. 31/10/22 <sup>1/2</sup> Colim living in Salangar Abra took the advantage being 198(19)/301/14 <sup>1/2</sup> me along and snatched my son Parjan after him to go back /506/1C <sup>1/2</sup> my son, knowing he was along with two other men who's 6/2/21 could not recognize them in the dark. He beats me taking 3/10/22 help of the three other men and tried to abduct me. Thanks <sup>ADAP</sup> <sup>1/2</sup> to the local people who were passing on the road rescued my life and my child from him.

It has been six months that I have left him. Being a teacher at Purulia I used to do up and down but he came in the train and threatened that he will murder me, push me down from the train or would throw acid on my face for that I have to leave Adra and go to Purulia to live.

Recently we have come to Adra for puja vacation, to Jayadhi but here threats have started again from last night. He is coming again throwing stones at our gate, honking on someone's bike abusing, use to tapping our door and asking to open up the gates.

This morning I went to the Thana to save from him but the moment I came back he was standing at our main gate with a local man saying that If I step to the Thana again he would disfigure me, cut my son into pieces and murder my grandfather.

Sir, stepping out in Adra is become unsafe for me and my mother's family we have no such man power to protect us from him and I do not want to live anymore with him so I request you to kindly look into the case and take action. Just for reference my kidnapping case has been filed in Adra Thana in the year 2015 also he harasses for money all the time and for every thing.
