Respected Sir,

In producing herewith one acqd. person namely Amit Kumar Das (41 Yrs) S/O Barid Baran Das of Vill-Kantaranguni DVC More Irani Para, PS- Adra, Dist- Purulia along with seized articles (1) 05 packets of Panda Bijli crackers (2) 06 packets of turkey Bijli crackers (3) 02 packets of Black Cat Chocolate Bombs (Fire crackers) (4) 02 packets of Penta Sky Falsh double Sound (Fire Crackers) (5) One Packet of Multiple aerial stars (Fire Crackers) (6) 45 Pieces of wall throwing Crackers (Fire Crackers) (7) One packets of Indigo colour Koti (Contain ten piece) (Fire Crackers) (8) One packets of Indigo Silver rain (Fire Crackers) net weight approx 07 KG with proper seizure list I beg to submit that today on 23.10.22 at 13.15 hrs when I was engage in Day mobile duty vide C.C No-3142/22 dtd. 23.10.2022 then received information from my source that a huge number of fire crackers have been sold by above noted persons at their shop/house at Kantaranguni DVC More Irani Para under Adra PS. I informed the matter to you and as per your kind order myself along with C/424 Naba Kumar Sao, C/522 Ruplal Tudu had been to the above noted place at 13.25 hrs. I parked the vehicle in a reasonable distance and cordoned the above noted shop by P.S. force. I detained 01 person and on asked he disclosed his identity as noted above and identified him salves as the owner of the above noted shop. I searched the shop of above noted Amit Kumar Das in presence of local disinterested witnesses and seized the above noted fire crackers from his shop with proper seizure list. I asked him to produce relevant documents regarding the said crackers but he failed to produce in favour of keeping, storing or selling of such combustible or fire articles. On asked he also confessed his guilt regarding committing of offence. Accordingly, I arrested them observing all arresting guidelines.

It is noted here that Honble High Court Calcutta passed an order in WPA (P) 292 with L.A. No.CAN 1 of 2022, Dtd 11.10.22, Sabuj Mancha and Anr Vs The state of West Bengal and others regarding prohibition of selling of firecrackers and directed the Police personnel for its strict compliance.

Hence I pray before you to start a case in this respect under proper section of law and arrange its investigation.
