Respected Sir,

In producing herewith 04 arested accd. persons namely (1) Dilip Gupta (62 Yrs) S/O Lt. Ramesh Ch. Gupta (2) Shivam Gupta (26 Yrs) S/O Dilip Gupta both of Chatna More Adra, (3) T.Santosh (29 Yrs) S/O T.Bhima Rao of Loco Colony, (4) B. Venket (39 Yrs) S/O Lt. B. Raja Rao of Traffic Colony all of PS- Adra, Dist- Purulia along with seized articles (1) 05 KGs of Gun Powder (Explosive) mixed with aluminum bits marked and labeled as Exhibit 'A' from which Two samples of 100 Gm each were taken, Marked and labeled as Exhibit-"A1" & "A2". (2) 100 Pcs of Fire crackers (Tubri) loaded/Made with Gunpowder and aluminum bits with proper seizure list and level.

I beg to submit that today on 23.10.22 at 19.35 hrs when I was engaged in Evening mobile duty vide GDE No-875 and C.C No-3144/22 dtd. 23.10.2022 then received information from my source that a huge number of fire crackers was being made by some persons at a room of unknown person behind a shop and beside the shop of Dilip Gupta at Chatna More Adra under Adra PS. I informed the matter to I/C Adra PS and as per his kind order myself along with C/1272 Bikash Chandra Patra, HG/51 Nilu Singh Sardar had been to the above noted place at 19.45 hrs. I parked the vehicle in a reasonable distance and cordoned the above noted room by P.S. force and I called two local witnesses namely (1) Md. Imtyaj S/O Md. Nasim of Vill-Ihariadih, PS-Adra, Dist-Purulia (Lottery Shop) and (2) Alok Paul S/O Lt. Saktipada Paul of Vill-Upper Beniasol, PS-Adra, Dist-Purulia (Pan Shop) and started searching at that place in front of witnesses. During search I found that above persons were making fire crackers and pushing Gunpowder inside Tubri, So I detained 04 persons and on asking they disclosed their identity as noted above and identified themselves as the worker of fire crackers factory. So I seized (1) 05 KGs of Gun Powder (Explosive) mixed with aluminum bits marked and labeled as Exhibit 'A' from which Two samples of 100 Gm each were taken, Marked and labeled as Exhibit-"A1" & "A2". (2) 100 Pcs of Fire crackers (Tubri) loaded/Made with Gunpowder and aluminum bits with proper seizure list and level. I asked them to produce relevant documents regarding the said Gun Powder and making Tubri but they failed to produce any valid documents in favour of making Tubri of such combustible or fire articles. On asked they also confessed their guilt regarding committing of offence. Accordingly, I arrested the above noted 04 accused persons with proper arrest memo and observing all arresting guidelines.

It is noted here that Honble High Court Calcutta passed an order in WPA (P) 292 with L.A. No.CAN 1 of 2022, Dtd 11.10.22, Sabuj Mancha and Anr Vs The state of West Bengal and others regarding prohibition of selling of firecrackers (Except green crackers) and directed the Police personnel for its strict compliance. So the above noted persons were violating the order of Hon'ble Court.

Hence I pray before you a case in this respect may kindly be started under proper section of law against (1) Dilip Gupta (62 Yrs) S/O Lt. Ramesh Ch. Gupta (2) Shivam Gupta (26 Yrs) S/O Dilip Gupta both of Chatna More Adra, (3) T.Santosh (29 Yrs) S/O T.Bhima Rao of Loco Colony, (4) B. Venket (39 Yrs) S/O Lt. B. Raja Rao of Traffic Colony all of PS- Adra, Dist- Purulia (5) Owner of the said room and arrange its investigation.
