Sir,

In producing herewith arrested accused person Shamchand Besra (29Yrs) S/o-Bhriguram Besra of vill- Banddih, PO- Ghatbera, PS-Balarampur, Dist- Purulia along with seized article i.e. black Colour Honda Shine S.P motorcycle bearing Registration No-JH05-BP/9894,

I beg to report that today (20.10.2022) myself along with C/222 Pravash Ch. Mandal (ii) HG1619 Madhusudan Paramanik (iii) Spl. HG/1857 Subodh Singh Mura and (iv) Spl HG/1858 Dinanath Singh Mura all of Arsha PS were performing Naka Checking duty at Palpal More under Arsha PS area vide Arsha PS C.C No. – 2148/22 dtd. 20.10.2022 and Arsha PS GDE No. – 731 Dtd 20.10.2022. At about 17.15 hrs, I found one black Colour Honda Shine S.P motor cycle bearing Registration No.- JH05-BP/9894 coming from Begunkodar side driven rashly and negligently without wearing helmet. We tried to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss / serious injury to nearby public due to his such riding. After a hot chase we could able to stop him at about 150 mt. away from Palpal Morh under Arsha PS. On being asked, he stated his name and address as noted above, but was unable to give any satisfactory account for his rash and negligent driving which could have endangered to human life. On being asked he could not able to produce any valid Driving License as well as valid documents in respect of the said motorcycle.

So, I seized said ash Colour Honda Super Splendor motorcycle bearing Registration No- JH05-BP/9894 in between 17.35 hrs and 17.55 hrs. and arrested him at 18.05 hrs as he had committed an offence punishable under sec 279 IPC and 181/194D MV Act 1988 in presence of police party and informed his family members accordingly.

Hence, I pray that a specific case U/S 279 IPC and 181/194D MV Act 1988 may kindly be initiated against accused Shamchand Besra (29Yrs) S/o-Bhriguram Besra of vill- Banddih, PO- Ghatbera, PS-Balarampur, Dist- Purulia.
