On 18/10/2022 at about 03:50 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1.Biswanath Barui,AE(S&LP) 2.Sankar Chandra Mahato, ACM 3. Sajal Kumar Mahanty, Sr. O.E. 4. Subhasis Mahato, Sr. O.E. entered the premises of Sri Gurucharan Kumar, S/O Sanatan Kumar of village - Kantadih, P.O. - Patahensal P.S- Bagmundi, Dist- Purulia and found Sri Gurucharan Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.2 KVA.
