I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Kurban Momin, S/O- Iyakup Momin of village - Kantadih, P.O. – Patahensal P.S- Bagmundi Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 18/10/2022 at about 04:10 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundih CCC along with 1.Biswanath Barui,AE(S&LP) 2.Sankar Chandra Mahato, ACM 3. Sajal Kumar Mahanty, Sr. O.E. 4. Subhasis Mahato, Sr. O.E. entered the premises of Sri Kurban Momin, S/O Iyakup Momin of village - Kantadih, P.O. - Patahensal P.S- Bagmundi, Dist- Purulia and found Sri Kurban Momin was enjoying electricity unauthorizedly drawing power from the nearest L &MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.2 KVA. As Sri Kurban Momin S/O- Iyakup Momin committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1.Sajal Kumar Mahanty, Sr.O.E. 2. Subhasis Mahato, Sr.O.E.
