Sub: Request for lodging F.I.R. against arrested accused person namely Fani Rajak (38 Yrs), S/O- Lt. Suru Rajak of Vill-Birgram, PS-Baghmundi, Dist-Purulia.

Sir,

In producing herewith arrested accused person namely Fani Rajak (38 Yrs), S/O- Lt. Suru Rajak of Vill-Birgram, PS-Baghmundi, Dist-Purulia along with seized one motor cycle bearing Reg No-JH 05W/9146 (IVS Star City). I beg to report that today myself along with 1) C/765 Lalmohan Murmu of Baghmundi PS, 2) C/843 Gourhari Mandal of SAP 11th Bn. Camp at Baghmundi PS were performing special mobile duty by Govt. vehicle heading towards Duarsini More under Baghmundi PS area vide Baghmundi PS C.C No- 1111/2022 dtd 28.10.2022 and Baghmundi PS GDE No- 1150 dtd. 28.10.2022. At about 13:05 hrs, I found near Duarsini More one TVS Star City motor cycle bearing Reg. No. JH 05W/9146 coming from Baghmundi side rashly and negligently. We tried to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he disclosed his identity as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he failed to produce his driving license and valid papers in support of said motorcycle.

So, I arrested him as he violated sec 279 IPC and 181/184 M.V Act at 13:35 hrs after marinating all arrest related guidelines and rules. I offered him for medical treatment but he refused. I also seized the vehicle with a view to prosecute him U/S 279 IPC and 181/184 M.V Act in presence of witnesses. The whole process of seizure was completed in between 13:15 hrs to 13.25 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S-279 IPC and 181/184 M.V Act may kindly be initiated against Fani Rajak (38 Yrs), S/O- Lt. Suru Rajak of Vill-Birgram, PS-Baghmundi, Dist-Purulia.
