Today on 14.10.2022 at about 18.30 hrs when I return back from Purulia with my 18(Eighteen) wheelers Trailer Truck vide its bearing Reg No- JH05AU4239 and reached at near Balarampur Bypass road on the way to Purulia - Balarampur Road (NH-32), suddenly one 22 (Twenty two) wheelers Trailer Truck vide its bearing Reg No-RJ14GL0500 overtook me from my back side in high speed which about to das with a rash & negligent way. So that I have to changed my way of path to avoid any untoward incident and somehow managed to stand my vehicle in road side.
