Sub: Prayer for starting a specific case against one Nandalal Mandi (24 yrs) S/O- Lt. Hiralal Mandi of Vill- Jopahari, P.O- Dhanudih, P.S- Baghmundi, Dist-Purulia (Motor Cycle Rider of having Regd. No-WB56R/1514, Bajaj Pulsar Black Colour).

Respected Sir,

With due respect I SI Goutam Kr. Mahata, beg to submit before you that on 19.10.2022 at about 14:45 hrs while myself along with force CI-2197 Mahadeb Gope, C/2210 Panchanan Doloi of Balarampur P.S were performing Special Mobile duty towards Dava side and Naka checking duty regarding remit of the rash driving duty vide Balarampur PS CC No-2797/22 Dated-19.10.2022 at near Rangadih Ram Mandir area on Balarampur – Baghmundi pitch Road. I found one Motor Cycle was coming from Baghmundi side towards Balarampur driving with dangerously in high speed. The Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and driving endangering to the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road users. We can able to apprehend him at near Rangadih Ram Mandir area. On interrogation he made incoherent statement at different time. He disclosed his identity as Nandalal Mandi (24 yrs) S/O- Lt. Hiralal Mandi of Vill- Jopahari, P.O- Dhanudih, P.S- Baghmundi, Dist-Purulia. On being asked he failed to produce any other valid documents of Motor Cycle, vide its registration No- WB56R/1514. Hence he violated the provision of Section 279 IPC & R/W Section-184 MV Act. So I seized the Motor Cycle having Regd. No- WB56R/1514, Engine No- DHXRLD76801 Bajaj Pulsar Black Colour at 14:55 hrs to 15:05 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Nandalal Mandi (24 yrs) S/O- Lt. Hiralal Mandi of Vill- Jopahari, P.O- Dhanudih, P.S- Baghmundi, Dist-Purulia at 15:25 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. I along with force returned to P.S with arrested accused also with seized articles. As the offence is bailable hence accused rider namely Nandalal Mandi was released on bail vide Balarampur P.S GDE No-733, date- 19.10.2022.

So I pray specific case may kindly be registered against the accused namely Nandalal Mandi (24 yrs) S/O- Lt. Hiralal Mandi of Vill- Jopahari, P.O- Dhanudih, P.S- Baghmundi, Dist-Purulia (Motor Cycle Rider having Regd. No- WB56R/1514, Bajaj Pulsar Black Colour) for committing offence U/S-279 IPC & R/W Section-184 MV. Act.
