Respected Sir,

With due respect & humble submission I beg to state that today on 22.10.2022 at 19:25 hrs received telephonic information by duty officer namely ASI Dulal Singh Sardar of Balarampur P.S that an accident was occurred at Balarampur Bypass road near Balarampur College on the way to Purulia - Balarampur Road (NH-32), vide Balarampur P.S GDE No- 839 date-22.10.2022 that one Car vide its registration No- JH05BW/9187 dashed to one motorcycle vide its registration No- WB56A/8919 (Red colour Hero Honda Splendor) by rough and negligence driving by the driver of the vehicle No- JH05BW/9187 and fled away the said car towards Purulia side. After receiving information and as per kind direction I, SI Sanjoy Banerjee along with force left P.S then and there to look into the matter vide Balarampur P.S GDE No- 840 date- 22.10.2022. I also directed to the on duty Police personals/ patrolling mobile van to deploy Naka checking duty at near Berada to detect and restrain the said offending vehicle. After arriving at the spot, we the Police party found that one motorcycle having its registration No- WB56A/8919 lying beside the road side and two motorcyclists were received grievous injury. I arranged to send them nearest Bansgarh CHC for medical treatment. After hot chasing by other force and Naka checking party managed to detain the said vehicle JH05BW/9187 near Berada area which was coming from Balarampur side by rash & negligent driving by the driver of the vehicle. I arrested the driver who disclosed his name as Vivek Kumar Mahato (23 yrs) S/O- Dasharath Mahato of Vill- Chilgu, P.O- Chilgu, P.S- Chandil, Dist- Saraikella Kharswan, Jharkhand after maintaining all formalities regarding the arrest and explained him the ground of arrest. I seized the offending vehicle vide its registration No- JH05BW/9187 (Super White colour Innova Car, Company Toyoto) after preparing proper seizure list and also seized the victim motorcycle having its registration No- WB56A/8919.

It is my humble request to you please takes a needful as well as lawful action against the driver of the said offending vehicle bearing Reg No- JH05BW/9187 and start a specific case against aforesaid named accused driver under proper section of law.
