To The Officer-in-charge Bandwan Police Station, Dist- Purulia,

Sir,

In producing here with 01 (one) arrested accused person namely Sarkar Mahato (21Y) S/O-Bhagbat Mahato of Vill-Oriya Bandih, PS-Komalpur, Dist-East Singhbhum JH along with one Motor Cycle (Honda shine 125) having number plate-JH-05CJ/4687, arrest memo & other relevant papers.

I beg to state that today (06.10.2022), in course of my spl. mobile duty (vide Bandwan PS GDE No- 200, Dtd 06/10/22) I had been to Bandwan - Barabazar road at about 18:45 hrs and found that the one person with his Motor Cycle (Honda shine 125) having number plate- JH-05CJ/4687 were driving roughly recklessly near Ashpara Mor (Bandwan-Barabazar road). Myself along with force tried to stop him but he drove the Motor Cycle at a high speed without paying least attention to us. We could able to detain him at near Bandwan-Barabazar Aspara More at a distance within a few minutes on Bandwan-Barabazar road under Bandwan PS area after a hot chasing. This rough and negligence driving may lead to an accident at any time. Being asked the above noted accused person could not be able to give any satisfactory answer for that reckless driving on road and such public place.

I arrested him at 19:05 hrs for such rough and negligent driving maintaining all legal procedures regarding arrest, Issued memo of arrest. I informed him regarding the ground of arrest and arranged for informing his relative. On being asked he did not produce the valid documents in respect of said motor cycle. I offered him medical checkup but he denied.

So, I also seized the above noted Motor cycle under proper seizure list duly signed by the accused person and police witnesses in between 19:10 hrs and 19:25 hrs then I took him to PS and kept in PS lock up maintaining all hazat procedures.

So, I therefore request you that a specific case may be started against him under proper section of law and arrange for its investigation.
