Sub: Complain against Lalit Sutradhar (20 Yrs) S/O- Shibu Sutradhar of vill-Dhabani, P.O-Saga Supururi, P.S- Bandwan, Dist-Purulia to start a Cog case U/S 46A(C) B.E. Act 1909.

## Respected Sir,

In producing here with arrested accused person namely Lalit Sutradhar (20 Yrs) S/O- Shibu Sutradhar of vill-Dhabani, P.O-Saga Supururi, P.S- Bandwan, Dist-Purulia along with seized Illicit Distill liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 29/10/22 at about 14:35 hrs. I received a credible source information that one person Lalit Sutradhar (20 Yrs ) S/O- Shibu Sutradhar of vill-Dhaboni, P.O-Saga Supururi, P.S- Bandwan, Dist-Purulia is stocking and carrying Illicit Distill liquor for selling without any valid license coming from Dhabani side. Accordingly, myself along with evening patrolling duty officer force (SI Suvajit Nandi, C/59 Dhiraj Ghosh and C/3218 Sukchand Mandi all are of Bandwan P.S. Dist-Purulia) vide Bandwan P.S. C.C. No. 4601/22 Dtd: 29/10/22 left PS to work out the said source information and I detained him at Aspara more, P.S-Bandwan Dist-Purulia at 14:45 hrs. We searched him and during search with the help of accompany officer and force, we found that the said person is stocking and carrying Illicit Distill liquor in a jarricane. Being asked, he disclosed that all liquor has been stocked and carried for the purpose of sell. On demand, he failed to produce any valid documents/License in respect of preparing, stocking and selling of Illicit Distill liquor. Accordingly, I seized all the Illicit Distill liquor (details in attached seizure list) at 14:55 hrs after preparing proper seizure list duly signed by the witnesses. One liter Illicit Distill liquor has been kept & labeled as sample bottle. Approx 10 liters Illicit Distill liquor has been seized. Then, I arrested him at 15:05 hrs maintaining all legal procedures regarding arrest as laid down by Hon'ble Supreme Court after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a Cog. case may kindly be started U/S 46A(C) B.E. Act 1909 against the arrested accused person namely Lalit Sutradhar (20 Yrs) S/O- Shibu Sutradhar of vill-Dhabani, P.O-Saga Supururi, P.S- Bandwan, Dist -Purulia and arrange for its investigation.
