Sub: Complain against Sachin Mahato (23 Yrs) S/O- Dalim Kr. Mahato of vill-Charakpahar, P.O-Kamalpur, P.S- Kamalpur, Dist-East Singhbhum JH to start a Cog case U/S 46A(C) B.E. Act 1909.

Respected Sir,

In producing here with arrested accused person namely Sachin Mahato (23 Yrs) S/O- Dalim Kr. Mahato of vill-Charakpahar, P.O-Kamalpur, P.S- Kamalpur, Dist-East Singhbhum JH along with seized Illicit Distill liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 30/10/22 at about 19:35 hrs. I received a credible source information that one person is stocking and carrying Illicit Distilled liquor for selling without any valid license at a line at Saga Supururi more Chandra, PS-Bandwan, Dist-Purulia. Accordingly, myself along with force (SI Suvajit Nandi, C/448 Dhiraj Ghosh and C/1463 Santimoy Ghosh all are of Bandwan P.S. Dist-Purulia) vide Bandwan P.S. C.C. No. 4608/22 Dtd: 30/10/22 left PS to work out the said source information and I along with force held raid and detained him at line hotel at Saga Supururi more Chandra, P.S- Bandwan Dist- Purulia at 20:10 hrs. We searched there at the line hotel room and premises and during search with the help of accompany officer and force, we found that the said person has stocked Illicit Distil liquor in two jarricane. Being asked, he disclosed his identity as noted above and confessed that all liquor has been carried and stocked for the purpose of selling. On demand, he failed to produce any valid documents/ License in respect of preparing or stocking or selling of Illicit Distill liquor. Accordingly, I seized all the Illicit Distill liquors with jarricanes (details in attached seizure list) in between 20:15 hrs to 20:40 hrs after preparing proper seizure list duly signed by the witnesses. One litre Illicit Distill liquor from each jarricane has been kept & labelled as sample bottle. Approx 40 liters Illicit Distil liquor has been seized. Then, I arrested him at 20:45 hrs maintaining all legal procedures regarding arrest as laid down by Hon'ble Supreme Court after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a Cog. case may kindly be started **U/S 46A(C) B.E. Act 1909** against the arrested accused person namely Sachin Mahato (23 Yrs) S/O- Dalim Kr. Mahato of vill-Charakpahar, P.O-Kamalpur, P.S- Kamalpur, Dist-East Singhbhum JH and arrange for its investigation.
