Subject: Complaint against Sukdeb Mahato (54 Yrs), S/O- Lt. Latu Mahato of Vill- Dighi, PS - Boro, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accused person Sukdeb Mahato (54 Yrs), S/O- Lt. Latu Mahato of Vill- Dighi, PS - Boro, Dist - Purulia with seized 22 (Twenty two) sealed bottles are containing 300 ml country spirit in each bottle styled as "Bumpher" and 01 (one) bottle seized as sample from there as sell proceed from the possession of above noted accused which were seized under proper seizure list.

I beg to submit that today (16/10/2022) during my evening mobile duty in between 18:55 hrs to 20.05 hrs acting on a secret source information I apprehended the above noted person in his house at Dighi village and found that above noted person illegally stocked and selling "Bumpher" to local public. On interrogation he disclosed his name and address as noted above. On demand he failed to produce any valid documents / License in respect of said illicit spirit which was kept in his house. Accordingly I seized 22 (Twenty two) sealed bottles are containing 300 ml country spirit in each bottle styled as "Bumpher" and 01 (one) bottle seized as sample from there as sell proceed under proper seizure list in presence of witnesses, which is enclosed herewith. As such he was arrested at 19.45 hrs u/s 46 A (C) B.E. Act. 1909 and during arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to the arrestee. Out of seized "Bumpher" country spirit 300 ml taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd. Sukdeb Mahato (54 Yrs), S/O- Lt. Latu Mahato of Vill- Dighi, PS - Boro, Dist - Purulia violate section 18(i) B.E. Act. For possession of intoxicating not obtained from a licensed vendor and in contravention and he committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid (1) C/ 974 Dilip Kr. Ghosh, (2) C/ 1250 Jitendra Kr. Dubey accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Sukdeb Mahato (54 Yrs), S/O- Lt. Latu Mahato of Vill- Dighi, PS - Boro, Dist - Purulia.
