Sub:-Request for lodging F.I.R. against driver of vehicle No- JH 09 AJ/2950 (Pick-up Van)

Sir,

In producing herewith seized vehicle bearing Reg. No. JH 09 AJ/2950 (Pick-up Van), I beg to submit that on 08.10.2022 I ASI Subhendu Mahato along with C/1580 Alam Ansary, HG/1781 Subhendu Sekhar Mahato all of Hura PS were performing day mobile duty vide Hura PS C.C No- 2294/22 dtd. 08.10.2022 and Hura PS GDE No-311, dtd- 08.10.2022 and while we reached at near Samukgoria morh under Hura PS (Purulia-Bankura NH60A road) on 08.10.2022 at about 11:45 hrs. we found one vehicle having Registration No. JH 09 AJ/2950 (Pick-up Van), was going towards Purulia side with rash and negligently and overturned on the road (Purulia-Bankura NH60A road) at Samukgoria (Boro Pull) under Hura PS. We rushed to the spot and found that the parts of body of the said vehicle has been damaged but none injured. On seeing police party the drivers fled away. The accident occurred due to rash and negligent driving of the driver of the said vehicle.

Accordingly, I seized the above noted vehicle by preparing seizure list (details are mentioned in the attached seizure list) with a view to prosecute

him U/S 279/427 IPC.

Hence I pray that a specific case U/S 279/427 IPC may kindly be initiated against the driver of vehicle bearing Reg. No. JH 09 AJ/2950 (Pickup Van) and arrange for its investigation.
