The matter was intimated to O/C Hura and as per his kind instruction I along with my accompanied force C/ 1580 Alam Ansari, C/ 838 Rakhal Mahato & C/1450 Uttam Mahapatra all of Hura PS rushed to Hura Bazar near Hattola (NH60A) at about 01.05 hrs and I also called officers and force from PS and also with the help of local people I managed to stop the all Total twenty three (23) vehicles bearing Regd No. 1. UP06BT1238-, 2.

BR44GA 2161 and found that Total Cattles 149 like Buffalo-80, Cow 24 Calf 45 were loaded in the vehicles (details are mentioned in the attached seizure list)

On being asked, they revealed their identity as noted above but their identities could not be verified as they could not produce any relevant document in respect of their address and age. On demand, they could not produce any papers in respect of the vehicle or the Cattles, and about the procurement of the cattle or vehicle. Not only that they have not any paper regarding transportation of the Cattles etc. The vehicle is not meant for transporting livestock as no livestock permit was available. They did not give satisfactory reason for transporting of Cattles by vehicles. They have stated incoherently and from their statements there is every reason to believe that they have procured the vehicle and the cattle in any fraudulent means or by means of theft after hatching up criminal conspiracy also trying to disburse those Cattle for personal gain. Moreover, they were carrying those cattle in the vehicle in such a manner that those cattle were concealing together for the want of space. The above noted accd persons treated the cattle in such a manner so as subject those to unnecessary cruelty as they loaded those in such a vehicle which does not measure sufficiently either in height, length or breadth. Hence, I seized those Total 149 Cattles and the vehicle noted above from the possessions of the above noted accd persons under proper seizure list and after seizure I also arrested them as they committed offence U/S- 379/411/414/429/ 120B IPC and U/S- 11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960. After that I brought the arrested accd persons by maintaining all formalities regarding arrest with the help of my accompanied officers and force. I also arranged postmortem of the died total 8 (eight) Cattles by the concern authority. The vehicle is not meant for transporting the cattle also. The cattle were illegally transporting cattle from other states for the purpose of illegal inter-state cattle smuggling.

I, therefore pray that a case may kindly be started against the arrested accused persons noted above and owner of the those vehicles and others U/S- 379/411/414/429/120B IPC and U/S- 11(1)(d) (e)(f) the prevention of cruelty to Animal Act 1960 and arrange its investigation.
