Sir,

In producing herewith 01 (One) arrested accused person namely (i) Aditya Nayak (42) S/O Lt. Rampada Nayak of Vill-Ichag, PS-Jhalda, Dist-Purulia under arrest along with seized articles as per seizer list i.e. (i) 20 (Twenty) Ltrs. ID Liquor (Cholai) in a Plastic Jarican (ii) 18 pieces of plastic glass under proper seizure with label.

1 PSI. Habibur Rahman of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (05/10/2022) myself along with (i) C/1207 Tarit Kr. Majhi (ii) HG/1681 Manmotha Kumar and (iii) NVF/1036 Pramatha Kuiry all of Jhalda PS were performing anti crime evening mobile duty (This refers to Jhalda PS CC No. 2277/22 dated 05/10/2022 and GDE No. 176 dated 05/10/2022. During evening mobile duty at about 19:45 hrs I received a credible source information that the above noted accused person selling ID Liquor from residential house situated at vill- Ichag, PS-Jhalda, Dist-Purulia. On receipt such information I immediately informed the matter to you and as per your kind direction I along with force proceeded to work out the information. We reached at vill- Ichag, PS-Jhalda, Dist-Purulia at about 20:15 hours and held raid in the house of Aditya Nayak and found that the accused person namely Aditya Nayak (42) S/O Lt. Rampada Nayak of Vill-Ichag, PS-Jhalda, Dist-Purulia selling ID Liquor from his house. Seeing the Police party the buyers are fled away. On searched (i) 20 (Twenty) Ltrs. ID Liquor (Cholai) in a Plastic Jarican (ii) 18 pieces of plastic glass were found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he are usually selling the same to the villagers illegally. So, finding no any other alternative I seized the above noted articles from the possession of the accused person and labelled, duly singed by the accused person & witnesses in which 500 ML of ID Liquor (Cholai) in a bottle from mother sample was kept as sample with label. During interrogation he confessed his guilt as such I arrested him after observing all the formalities as per law issuing memo of arrest as the accused person are liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely (i) Aditya Nayak (42) S/O Lt. Rampada Nayak of Vill-Ichag, PS-Jhalda, Dist-Purulia U/S- 46 (A) (c) of the Bengal Excise Act 1909.
