Sir,

I, SI- Sajal Kanti Panda along with force returned to PS and brought under seizure one Truck having Reg. No- JH 02F 3738 loaded with approx 4 MT steam coal (Dust) under proper seizure list and produced before your good self.

The fact in brief is that today (16/10/2022) myself along with (i) JC/1371 Bishal Saw (ii) C/331 Mansaram Kumar (iii) NVF/1036 Pramatha Kuiry & (iv) HG/1636 Harekrishna Ghosh all of Jhalda PS left P.S. for performing anticrime patrolling duty vide GDE No. 624/22 dt. 16/10/2022 in consonance with Jhalda PS C.C. No- 2369/22 date- 16/10/2022. During the patrolling duty at about 20:05 hrs received a tip off that an unauthorized truck loaded with steam coal (Dust) was coming from Jharkhand side along Purulia Ranchi road and had been proceeding towards Purulia. Subsequently, I informed to you and as per your kind order I started Naka at Nayamore by placing the guardrail on the Purulia Ranchi Road. Accordingly, the said truck loaded with steam coal (Dust) arrived at the Nayamore and we intercepted the said Truck at Naka checking point at about 20:25 hrs and I found the said truck loaded with steam coal (Dust) as identical as I previously received the information. But seeing the Police, driver of Truck fled away leaving the Truck on road before Naka checking point. We tried to apprehend him but failed. We waited for reasonable time but none came to spot. So, It was ascertained that the driver of the truck having no JH 02F 3738 loaded the said steam coal (Dust) in cahoots with the owner of the vehicle and others by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. On searching it was found that the said Truck was loaded with approx 4 (four) MT steam coal (Dust). Subsequently, I seized the truck having registration no. JH 02F 3738 loaded with approx 4 (four) MT steam coal (Dust) under proper seizure list duly signed by available witnesses. Though, I searched for the public witness but none was available there at that time. Thereafter, I arrived at PS with the seized truck with loaded steam coal.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the track having registration no. JH 02F 3738 and others as they committed offence U/S- 379/411/414/120B of the IPC.
