Respected Sir,

In producing here with 01(One) arrested accused person namely Bibek Mahato (23) S/O Narayan Mahato of Vill- Gokulnagar, PS- Jhalda, Dist- Purulia and along with seized 01(one) Tractor having Engine no- S325L31610 and Chassis No- NHN30370ZMA534776 loaded with sand trolley approx 100 cft . The fact in brief is that on (17/18.10.2022) I along with force namely (i) C/1284 Pratapaditya Majhi (ii) C/1207 Tarit Kr. Majhi, (iii) HG/1681 Manmatha Kumar, (iv) HG/1636 Harekrishna Ghosh were performing night mobile duty in PS area vide Jhalda P.S. GDE No- 678 Dated- 17/10/2022 in consonance with Jhalda PS CC No-2379/22 Dated- 17/10/2022. During my night mobile duty I received credible source information that one Tractor was lifting & carrying sand illegally and coming from Shyamnagar Ghat under Jhalda PS towards Jhalda Town. Subsequently, I informed you and as per your gracious order, I placed Naka at Gokulnagar More to work out this tip off and started Naka Checking after proper placing guard rail on the Jhalda Bagmundi road. Thereafter I saw the one Tractor was proceeding towards Jhalda Town. Consequently, we intercepted the said Tractor at before Naka checking point on 18/10/2022 at about 05:55 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party driver who was on that vehicle (Tractor) started to flee away. After hot chase we managed to apprehend him. On being asked, the driver of the vehicle disclose his name noted in the supra. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded with sand trolley. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand loaded trolley. I repeatedly asked the driver to produce the valid papers but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the driver of the Tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Subarnarekha River from Shyamnagar Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized the Tractor having Engine No - S325L31610 and Chassis No- NHN30370ZMA534776 attached with loaded sand trolley (Approx 100 cft) under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Bibek Mahato (23) S/O Narayan Mahato of Vill- Gokulnagar, PS- Jhalda, Dist- Purulia after informing the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said Tractor to Jhalda PS compound. .

Under the above facts and circumstances kindly take lawful action against the driver namely Bibek Mahato (23) S/O Narayan Mahato of Vill- Gokulnagar, PS- Jhalda, Dist- Purulia and the Owner of the said vehicle as they committed an offence U/S 379/411/414/120B of the IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.
