In producing here with the arrested accused persons namely (i) Bablu Mahato (38) S/O Lt. Banshidhar Mahato and (ii) Gopal Bagti (25) S/O Pashupati Bagti both of Vill- Kansra, PO-Mosina, PS-Jhalda, Dist-Purulia and brought under seizure of the following articles i.e. (i) 25 (Twenty five) Pcs sealed bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup styled as Onrex Cough Syrup @ 154.50/- per bottle, having 100 ml in each bottle in a Green & White Colour Plastic bag (ii) 7 (Seven) packets Nitrazepam Tablets IP styled as Nitrosun-10, containing 5 strips of 2 x 10 tablets in each packets in a Green & White Colour Plastic bag and (iii) One light green colour Hero Splendor i-smart Motor Cycle having Reg. No- JH 08D 0359 as mentioned above. I SI- Sujit Das of Jhalda PS do here by lodged a written complaint against (i) Bablu Mahato (38) S/O Lt. Banshidhar Mahato and (ii) Gopal Bagti (25) S/O Pashupati Bagti both of Vill- Kansra, PO-Mosina, PS-Jhalda, Dist-Purulia to the effect that today (20/10/2022) while performing evening mobile duty (This refers to Jhalda P.S. GDE No- 820 Dt- 20/10/2022, vide C.C. No-2415/22 Dt- 20/10/2022) at Mosina More. I received an information from my source at about 17:05 hrs that 02 (two) persons, namely Bablu Mahato & Gopal Bagti were coming from Ramgarh side under Jharkhand state and going towards Jhalda Town via Jhalda Gola Road carrying huge quantity of Cough Syrup & Tablets in a Green & white colour bag for selling clandestinely to the youth customers of Jhalda town area. On receiving this information I immediately informed to you and the duty officer for noting down the information. Subsequently, as per your gracious direction, I SI- Sujit Das along with (i) C/04 Abhadut Kumar, (ii) NVF/778 Samir Kr. Mahato (iii) HG/1681 Manmatha Kumar and (iv) HG/1772 Fatik Ch. Kumar all of Jhalda PS left Mosina more immediately to work out the information. We all reached with Govt. Vehicle at Dumurdih village near bridge at 17:20 Hrs and started Naka. Thereafter at about 17:45 hrs I found that 02 (two) persons riding in a green colour motorcycle from Jharkhand side towards Jhalda with a Green & white colour bag as identical as I received information. Subsequently, I intercepted the motorcycle and searched and found that (i) 25 (Twenty five) Pcs sealed bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup styled as Onrex Cough Syrup @ 154.50/- per bottle, having 100 ml in each bottle in a Green & White Colour Plastic bag from exclusive possession of the accused Bablu Mahato (38) S/O Lt. Banshidhar Mahato of Vill- Kansra, PO-Mosina, PS-Jhalda, Dist-Purulia (ii) 7 (Seven) packets Nitrazepam Tablets IP styled as Nitrosun-10, containing 5 strips of 2 x 10 tablets in each packets in a Green & White Colour Plastic bag from exclusive possession of the accused Gopal Bagti (25) S/O Pashupati Bagti both of Vill- Kansra, PO-Mosina, PS-Jhalda, Dist-Purulia and (iii) One light green colour Hero Splendor i-smart Motor Cycle having Reg. No- JH 08D 0359 from the exclusive possession of the accused Bablu Mahato (38) S/O Lt. Banshidhar Mahato of Vill- Kansra, PO-Mosina, PS-Jhalda, Dist-Purulia. On interrogation they disclosed their identity as mentioned above and they also said that they collected these illegal cough syrup from Ramgarh side under Jharkhand state. On demand they failed to produce any valid documents/license in respect of keeping huge quantity of illegal Drugs. So I seized the same under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and as well as signed by the apprehended persons and also prepared label with seal and from which 01 (one) bottle of cough syrup was kept as sample and out of which 01 (one) strips is collected as sample. They also disclosed that they were running Cough Syrup (illegal drugs) business and they were carrying the said syrup for the purpose of selling to the local youth customers. Subsequently, I arrested the accused persons namely (i) Bablu Mahato (38) S/O Lt. Banshidhar Mahato and (ii) Gopal Bagti (25) S/O Pashupati Bagti both of Vill- Kansra, PO-Mosina, PS-Jhalda, Dist-Purulia for violating the Sec-27 of Drugs & Cosmetics Act-1940 after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a case against accused persons namely (i) Bablu Mahato (38) S/O Lt. Banshidhar Mahato and (ii) Gopal Bagti (25) S/O Pashupati Bagti both of Vill- Kansra, PO-Mosina, PS-Jhalda, Dist-Purulia and others U/S 27 of Drugs & Cosmetics Act-1940 and arrange for its investigation.
