Sir,

In producing here with the arrested accused persons namely (i) Dinesh Mahato (40) S/O Lt. Mukunda Mahato of Vill-Chandai, PS-Jhalda, Dist-Purulia and (ii) Sitaram Mahato (38) S/O Lt. Jhagru Mahato of Vill-Mahultanr, PS-Jhalda, Dist-Purulia and brought under seizure of the following articles i.e. (i) 06 (Six) Ltrs. ID Liquor (Cholai) in a plastic carry bag in a bag (ii) 06 (Six) Ltrs. ID Liquor (Cholai) in a plastic carry bag in a bag (iii) One black colour Hero Honda Motor Cycle having Reg. No- JH 02G 2551 as mentioned above. I SI- Prasanta Sau of Jhalda PS do here by lodged a written complaint against the above noted two persons to the effect that today (22/10/2022) while performing evening mobile duty (This refers to Jhalda P.S. GDE No- 898 Dt- 22/10/2022, vide C.C. No-2430/22 Dt- 22/10/2022) at Gokulnagar More, I received an information from my source at about 18:15 hrs that 02 (two) persons, namely Dinesh Mahato & Sitaram Mahato were coming from Ichag side towards Jhalda Town carrying huge quantity of ID Liquor in 02 (two) bag for selling clandestinely to the youth customers of Jhalda town area. On receiving this information I immediately informed to you and the duty officer for noting down the information. Subsequently, as per your gracious direction, I SI- Prasanta Sau along with (i) C/1496-Subal Ch. Mahato, (ii) NVF/778 Samir Kr. Mahato (iii) HG/1681 Manmatha Kumar and (iv) NVF/1036-Pramatha Kuiry all of Jhalda PS left for Kashidih more immediately to work out the information. We all reached with Govt. Vehicle at Khamar GP near Kashidih more at 19:05 Hrs and started Naka. Thereafter at about 19:15 hrs I found that 02 (two) persons riding in a black colour motorcycle from Ichag side with 02 (two) bag as identical as I received information. Subsequently, I intercepted the motorcycle and searched and found that (i) 06 (six) ltr. ID Liquor in a Plastic bag from exclusive possession of the accused Dinesh Mahato (40) S/O Lt. Mukunda Mahato of Vill-Chandai, PS-Jhalda, Dist-Purulia and (ii) 06 (six) ltr. ID Liquor in a Plastic bag from exclusive possession of the accused Sitaram Mahato (38) S/O Lt. Jhagru Mahato of Vill- Mahultanr, PS-Jhalda, Dist-Purulia and (iii) One black colour Hero Splendor Motor Cycle having Reg. No- JH 02G 2551 from the exclusive possession of the accused Dinesh Mahato (40) S/O Lt. Mukunda Mahato of Vill-Chandai, PS-Jhalda, Dist-Purulia. On interrogation they disclosed their identity as mentioned above and they also said that they collected this illegal ID Liquor from Khamar side under Jhalda PS area. On demand they failed to produce any valid documents/license in respect of keeping huge quantity of ID Liquor. So I seized the same under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and as well as signed by the apprehended persons and also prepared label with seal and from which 175 ml of both plastic carry bag was kept as sample. They also disclosed that they were running ID Liquor business and they were carrying the said ID liquor for the purpose of selling to the local youth customers. Subsequently, I arrested the accused persons namely (i) Dinesh Mahato (40) S/O Lt. Mukunda Mahato of Vill-Chandai, PS-Jhalda, Dist-Purulia and (ii) Sitaram Mahato (38) S/O Lt. Jhagru Mahato of Vill- Mahultanr, PS-Jhalda, Dist-Purulia for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I, therefore pray before you to start a case against accused persons namely (i) Dinesh Mahato (40) S/O Lt. Mukunda Mahato of Vill-Chandai, PS-Jhalda, Dist-Purulia and (ii) Sitaram Mahato (38) S/O Lt. Jhagru Mahato of Vill- Mahultanr, PS-Jhalda, Dist-Purulia for prosecution U/S-46A (c) of the Bengal Excise Act 1909 and arrange for its investigation.
