In producing herewith one arrested accused person namely Ranjit Karmakar @ Bablu (42 yrs) S/o-Bari Karmakar of Vill-Garafushro PS-Purulia (M), Dist-Purulia under arrest along with seized articles as per seizure list i.e. (1) 09 (nine) bottles KINFISHER STRONG PREMIUM BEER each bottle 650 ML with sealed condition (2) 08 (eight) bottles DILKHUSH country sprit each bottle 600 ML with sealed condition and each of 01 bottle labeled as sample.

I ASI Swapan Mandal of Joypur PS do hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (14/10/2022) at about 14:25 hrs when myself along with C/-516 Chandra Shekhar Mahato, C/-1356 Rajib Kundu & C/-1358 Sanjib Kr Patra were performing special raid duty vide Joypur PS C.C. No-3569/22 Date-14/10/2022, as per my source information I reached at New Banarasi Hotel beside NH-32 at Kathaltard under Joypur PS and found that the above noted accused person selling the above noted seized articles in his shop. On seeing Police persons, he concealed his presence at that shop, but on searching we could trace out him and also found the above noted seized articles in his hotel. On being asked he disclosed his name and address. On interrogation he stated that he was selling the said liquor to the local people in Kathaltard village area after collecting from other side but on demand he failed to produce any valid documents in respect of selling such intoxicating liquor. So it is reasonable to believe that he was selling the said liquor illegally without any documents. So I seized the same under proper seizure list in between 15:05 hrs to 15:15 hrs & labeled the same, duly signed by him and other available witness after taking each of 01 piece labeled as sample out of rest seized articles. During further interrogation he confessed his guilt as such I arrested him today 14/10/2022 at 15:25 hrs abiding by all the procedure laid down in Cr.P.C and the latest guidelines of the Apex Court as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Ranjit Karmakar @ Bablu (42 yrs) S/o-Bari Karmakar of Vill-Garafushro PS-Purulia (M), Dist-Purulia, U/S-46A (c) of the Bengal Excise Act 1909.
