Sir,

In producing herewith 01 (one) arrested accused person Sristidhar Rajwar (52 yrs) S/o-Late Bholanath Rajwar of Vill-Gowaladih PS-Joypur Dist- Purulia, under arrest along with seized articles as per seizer list i.e. (1) 02 (two) Liter illicit liquor with white color jarican (2) 10 (ten) Liter illicit liquor with 02 (two) plastic packed each packed 05 liter (locally known as Mohulla) under proper seizure with label.

I SI Nagendra Nath Das of Joypur PS hereby lodged a written complaint against the above noted arrested accused person, to the effect that on today (16/10/2022) at about 16:45 hrs when myself along with C/-1434 Jaganntah Mandal, C/-1358 Sanjib Kr Patra both of Joypur PS were performing special mobile duty vide Joypur PS CC No-3550 Date-16/10/2022, as per my source information I reached at Gowaladih more under Joypur PS and found that the above noted accused person selling illicit liquor (Mohula) in the house of Sristidhar Rajwar S/o-Late Bholanath Rajwar of Vill-Gowaladih PS-Joypur Dist- Purulia. On seeing Police person, he conceal his presence at that place, but on searching we able to trace out him and also to found that 12 (Twelve) liter of Illicit Liquor (locally known as Mohulla) which was kept at his house. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit liquor to the local people in the area. On demand he failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that he was selling the Id liquor (Mohula) illegally without any documents. So I seized the same under proper seizure list in between 18:55 hrs to 19:10 hrs & label duly signed by him and other available witness after taking 300 ML as sample in a separate bottle.

During further interrogation he confessed his guilt as such I arrested him today 16/10/2022 at 19:15 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Sristidhar Rajwar (52 yrs) S/o-Late Bholanath Rajwar of Vill-Gowaladih PS-Joypur Dist- Purulia U/S-46A (c) of the Bengal Excise Act 1909.
