your notice. My brother Neeraj Upadhyay (S/o Rakesh Ranjan Upadhyay  
Address: Near Middle School Barmasia, Dhanbad Jharkhand - 826001 was  
employed in 'Bhandhan Bank' Purulia main branch & was on official duty  
travelling from Purulia to Jhalda on 19 Oct 2022 at 11:40 am approx  
on his motorcycle Reg No. JH10AS9639 met with an accident near  
CAN public school Joypur hit by a tractor Reg No. JH09BA9162 due  
to the negligence driving by the tractor driving on wrong side of  
the road. Later he was taken to the DEVEN MAHATO GOVERNMENT  
MEDICAL COLLEGE AND HOSPITAL Purulia. He was declared brought dead  
by the hospital (U/D Case NO. 844/22 dtd - 19 Oct 2022) at Purulia (T) PS Purulia.
