Sub: Prayer for starting a specific case against one Sambhu Kumar (27 yrs) S/o-Uchit Kumar of Vill-Chamchaka Shyampur PS-Kotshila Dist-Purulia Motor Cycle Rider having Regd. No-JH10BP-7721 (Hero Splendor+ Black & Red Colour).

Respected Sir,

With due respect I ASI Dhritiman Rakshit, beg to submit before you that on 25/10/2022 at about 08:35 hrs while myself along with C/-2629 Jayanta Kapat, HG/-1717 Phanibhushan Mahato were performing Special Mobile-I duty vide Joypur PS CC No-3654/22 Dated-25/10/2022 near Shasi Moreunder Joypur on Joypur-Pundag Road. I found one Motor Cycle was coming from Joypur side towards Pundag with Driving **Dangerously**. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life driving the Motor Cycle which may cause any time accident to the road user. Somehow we can able to apprehend him near Shasi Moreunder Joypur on Joypur-Pundag Road. On interrogation he made incoherent statement at different time. He disclosed his identity as Sambhu Kumar (27 yrs) S/o-Uchit Kumar of Vill-Chamchaka Shyampur PS-Kotshila Dist-Purulia. Hence he violated the provision of Section 279 IPC & R/W Section-184 MV Act. So I seized the Motor Cycle having Regd. No- JH10BP-7721 (Hero Splendor+ Black & Red Colour) at 10:45 hrs to 11:05 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Sambhu Kumar (27 yrs) S/o-Uchit Kumar of Vill-Chamchaka Shyampur PS-Kotshila Dist-Purulia at 11:10 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailable hence accused rider namely Sambhu Kumar was released on bail.

So I pray a specific case may kindly be registered against the accused namely Sambhu Kumar (27 yrs) S/o-Uchit Kumar of Vill-Chamchaka Shyampur PS-Kotshila Dist-Purulia Motor Cycle Rider having Regd. No-JH10BP-7721 (Hero Splendor+ Black & Red Colour) for committing offence U/S-279 IPC & R/W Section-184 MV. Act
