Sub: Prayer for starting a specific case against one Amal Kumar (29 yrs) S/o-Late Jodharam Kumar of Vill-Bararola PS-Kotshila Dist-Purulia Motor Cycle Rider having Regd. No- JH09AM-6634 (Hero Splendor+).

Respected Sir,

With due respect I SI Nagendranath Das, beg to submit before you that on 25/10/2022 at about 08:45 hrs while myself along with C/-857 Chepual Murmu, C/-985 Laxman Ch Majhi, C/-516 Chandra Shekhar Mahato & NVF/-1021 Bablu Mahato were performing Special Naka duty vide Joypur PS Special CC No-99/22 Dated-25/10/2022 near **Ritudih** More under Joypur on Joypur-Pundag Road. I found one Motor Cycle was coming from Pundag side towards Joypur with Driving **Dangerously**. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life driving the Motor Cycle which may cause any time accident to the road user. Somehow we can able to apprehend him near Ritu More under Joypur on Joypur-Pundag Road. On interrogation he made incoherent statement at different time. He disclosed his identity as Amal Kumar (29 yrs) S/o-Late Jodharam Kumar of Vill-Bararola PS-Kotshila Dist-Purulia Motor. Hence he violated the provision of Section 279 IPC & R/W Section-184 MV Act. So I seized the Motor Cycle having Regd. No- JH09AM-6634 Hero Splendor+ at 11:35 hrs to 11:45 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Amal Kumar (29 yrs) S/o-Late Jodharam Kumar of Vill-Bararola PS-Kotshila Dist-Purulia at 11:50 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailble hence accused rider namely Amal Kumar was released on bail.

So, I pray a specific case may kindly be registered against the accused namely Amal Kumar (29 yrs) S/o-Late Jodharam Kumar of Vill-Bararola PS-Kotshila Dist-Purulia Motor Cycle Rider having Regd. No-JH09AM-6634 (Hero Splendor+) for committing offence U/S- 279 IPC & R/W Section-184 MV. Act.
