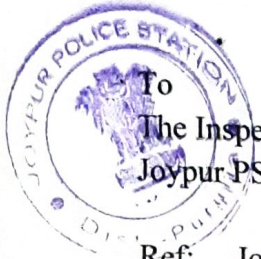

Sir,

In producing herewith 01 (one) arrested accused person Fichiya Kumar (36 yrs) S/o-Ajit Kumar of Vill-Barabendya PS-Joypur Dist- Purulia, arrest along with seized articles as per seizer list i.e. (1) 10 (ten) bottle of country spirit each of 600 ml styled as "DILKHUSH" (2) 10 (ten) liter illicit liquor under proper seizure with label.

I PLSI Sumana Kar of Joypur PS hereby lodged a written complaint against the above noted arrested accused person, to the effect that on today (01/10/2022) at about 14:35 hrs when myself along with C/-2620 Jayanta Kapat, NVF-803 Ankur Ch. Mahato of Joypur PS were performing SPL-II mobile duty vide Joypur PS CC No-3441/22 Date-01/10/2022, as per my source information I reached at Shasi More under Joypur PS in the grocery shop of Fichiya Kumar S/o-Ajit Kumar of Vill-Barabendya PS-Joypur Dist- Purulia and found that the above noted accused person selling illicit & country spirit liquor in the grocery shop. On seeing Police person, he concealed his presence at that place, but on searching we able to trace out him and also found that (1) 10 (ten) bottle of country spirit each of 600 ml styled as "DILKHUSH" (2) 10 (ten) liter illicit liquor which were kept in a white colour Jarican at his shop. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling illicit liquor to the local people in that area. On demand he failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 18:15 hrs to 18:45 hrs & labeled the same, duly signed by him and other available witnesses.

During further interrogation he confessed his guilt subsequently I arrested him abiding by all the procedure as laid down in Cr. PC and the latest guide lines of the Apex Court as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Fichiya Kumar (36 yrs) S/o-Ajit Kumar of Vill-Barabendya PS-Joypur Dist- Purulia U/S-46A (c) of the Bengal Excise Act 1909.
