Sir,

In producing herewith arrested accused person Ajoy Mahato (20 Years) S/O Satyaban Mahato of village - Ghutlia, PS - Kashipur, Dist - Purulia along with seized article i.e. one Black Colour 'Hero Honda Passion Pro' Motor Cycle having Registration No JH 09R/0652.

I beg to report that today myself along with C/416 Sahadeb Hansda and NVF/693 Jayanta Sing Sardar both of Kashipur PS were performing mobile duty near Talajuri PHC under Kashipur PS area vide Kashipur PS C.C No - 2709/22 dtd.06.10.2022 and Kashipur PS GDE No - 213 Dtd 06.10.2022. At about 18.35 hrs, I found one Black Colour 'Hero Honda Passion Pro' Motor Cycle coming from Kashipur side towards Chhatna rashly and negligently without wearing Helmet. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such riding. After a hot chase we could able to stop him near Near Talajuri Smt High School on Kashipur -Chhatna main road under Kashipur PS. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On being asked he failed to produce any relevant documents in respect of his motorcycle having Registration No JH 09R/0652.

So, I seized the said motor cycle having Registration No JH 09R/0652 in between 18.45 hrs and 18.55 hrs and arrested him at 19.05 hrs as he had committed an offence punishable under sec 279 IPC and 184/194D MV Act 1988 in presence of police party and informed his family members accordingly.

Hence, I pray that a specific case U/S 279 IPC and 184/194D MV Act 1988 may kindly be initiated against accused Ajoy Mahato (20 Years) S/O Satyaban Mahato of village - Ghutlia, PS -Kashipur, Dist – Purulia.
