

Sub: To lodge FIR against owner and driver of 02(two) seized tractors (1) Swaraj 834 (Blue Colour) Tractor having Registration No WB81/1661 along with trolley (without number plate) loaded with sand approx 70-80 Cft and 02(two) Belcha, 02(two) Dhama (2) Mahindra 265 DI (Red Colour) Tractor without No plate, Chasis No- MBNABACAAMRJ09619, Engine No- RMJ2BBN11864, along with trolley (without number plate) loaded with sand approx 90-100 Cft, and 02(two) Belcha, 02(two) Dhama.

Sir.

In producing herewith 02(two) seized tractors (1) Swaraj 834 (Blue Colour) Tractor having Registration No WB81/1661 along with trolley (without number plate) loaded with sand approx 70-80 Cft. and 02(two) Belcha, 02(two)Dhama (2) Mahindra 265 DI (Red Colour) Tractor without No plate, Chasis No- MBNABACAAMRJ09619, Engine No- RMJ2BBN11864, along with trolley (without number plate) loaded with sand approx 90-100 Cft. and 02(two) Belcha, 02(two) Dhama.

The nub of the fact in a nutshell is that on 14.10.2022 at 08.35 hrs I ASI Shibram Bauri of Kashipur PS along with (i) C/-2827 Kallol Duley and (ii) C/628 Giridhari Bauri both of Kashipur PS, Dist-Purulia, left the PS for performing day mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 540 dtd- 14.10.2022 and C.C No. 2764/22, Dtd- 14.10.22. During my mobile duty, I received a tip off at 14.45 hrs that some persons were loading some tractors with sand from the river bed of Darkeswar River near Siulibari village of under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trollies of said tractors. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolley) at Darkeswar River and fled away from the spot. We rushed to the Tractors and detained the said tractors. We searched the said tractors and found that the tractors were loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending Tractor. Hence, I seized the above noted tractors along with trolley loaded with sand and other articles in between 15.15 hrs to 15.45 hrs and brought the said seized articles to Kashipur PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolley for investigation.
