In producing herewith arrested accused Uttam Mandal (44 Years) S/O Lt Bholanath Mandal of village - Bhalagora, PS - Kashipur, Dist - Purulia along with seized articles, I beg to report that on 18.10.2022 at 14.55 hrs during my mobile duty vide Kashipur PS CC No 2796/22 Dt 18.10.2022 received telephonic information that the above noted accd selling liquor at Bhalagora village in his house. Accordingly I, SI Pratap Ch Ojha along with C/628 Giridhari Bauri and C/2925 Manoranjan Das reached at Bhalagora village in his house of the above noted accused at 15.20 hrs and found that one person was selling Liquor in his house. After seeing police party liquor customers fled away from the spot. On demand the seller disclosed his identity as Uttam Mandal(44 yrs) s/o- Lt.
