Sub – Prayer for lodging FIR.

Respected Sir,

In producing herewith arrested accused Uttam Mandal (44 Years) S/O Lt Bholanath Mandal of village – Bhalagora, PS - Kashipur, Dist - Purulia along with seized articles, I beg to report that on 18.10.2022 at 14.55 hrs during my mobile duty vide Kashipur PS CC No 2796/22 Dt 18.10.2022 received telephonic information that the above noted accd selling liquor at Bhalagora village in his house. Accordingly I, SI Pratap Ch Ojha along with C/628 Giridhari Bauri and C/2925 Manoranjan Das reached at Bhalagora village in his house of the above noted accused at 15.20 hrs and found that one person was selling Liquor in his house. After seeing police party liquor customers fled away from the spot. On demand the seller disclosed his identity as Uttam Mandal(44 yrs) s/o- Lt. Bholanath Mandal of village- Bhalagora, PS- Kashipur, Dist- Purulia but he failed to produce any valid document for selling liquor in his possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) 30 (Thirty) Bottles of CS liquor labeled as “Dil khush” 600 ML each was kept in his store room which I have seized under proper seizure list out of seized liquor 01 bottle taken up as sample with sealed and labeled. I also seized and labeled the seized articles at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person at 15.55 hrs u/s - 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case u/s 46(A)(c) B.E. Act 1909 against arrested accused Uttam Mandal (44 Years) S/O Lt Bholanath Mandal of village – Bhalagora, PS - Kashipur, Dist - Purulia and arrange for its investigation.
